

# Daily Report 207/2019


2 September 2019<sup>1</sup>

#### **Summary**

- Compared with the previous reporting period, between the evenings of 30 and 31 August, the SMM recorded a similar number of ceasefire violations in both Donetsk and Luhansk regions.
- Between the evenings of 31 August and 1 September, the Mission recorded more ceasefire violations in both Donetsk and Luhansk regions, compared with the previous 24 hours.
- On 30 August, the SMM saw fresh damage from shelling and gunfire in Pikuzy. On 1 September, while conducting an impact site assessment in the village, the Mission saw and heard an explosion 30m from its position.
- The SMM saw that the former forward positions of the Ukrainian Armed Forces and
  of the armed formations inside the Stanytsia Luhanska disengagement area continued
  to be dismantled.
- The Mission saw weapons in violation of withdrawal lines on both sides of the contact line.
- The SMM monitored adherence to the ceasefire to facilitate the operation of essential civilian infrastructure and to enable the drilling of wells near Raivka.
- Restrictions of the Mission's access continued, including at checkpoints near nongovernment-controlled Zaichenko, Petrivske, Lukove and Verkhnoshyrokivske, as well as at a heavy weapons holding area in a government-controlled area of Donetsk region.\*





# Ceasefire violations observed by the SMM 1 September 2019



In Donetsk region, between the evenings of 30 and 31 August, the SMM recorded a similar number of ceasefire violations, including, however, fewer explosions (77), compared with the previous reporting period (about 160 explosions). The majority of ceasefire violations were recorded at southerly directions of Chermalyk (government-controlled, 31km north-east of Mariupol), in areas south of the Donetsk Filtration Station (DFS) (15km north of Donetsk) and in areas south-west of Svitlodarsk (government-controlled, 57km north-east of Donetsk), where 43 undetermined explosions were recorded.

Between the evenings of 31 August and 1 September, the Mission recorded more ceasefire violations, including 118 explosions, compared with the previous 24 hours. The majority of the ceasefire violations, including the majority of explosions, were recorded in areas between Hnutove (government-controlled, 20km north-east of Mariupol) and Zaichenko (non-government-controlled, 26km north-east of Mariupol), in areas east of Pavlopil (government-controlled, 26km north-east of Mariupol), in areas south-east of Chermalyk and at easterly, southerly and westerly directions of Svitlodarsk.

In Luhansk region, between the evenings of 30 and 31 August, the SMM recorded a similar number of ceasefire violations, however no explosions, compared with the previous reporting period (11 explosions).

Between the evenings of 31 August and 1 September, the Mission recorded more ceasefire violations, including 42 explosions, compared with the previous 24 hours. The majority of the ceasefire violations were recorded in areas close to the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see *Other disengagement areas*).

#### Damage from gunfire and shelling in Pikuzy

On 30 August, the SMM saw that the second floor and the north-west-facing side of the roof of the Culture House on Akhmatovoi Street in the centre of Pikuzy (formerly Kominternove, non-government-controlled, 23km north-east of Mariupol) were smouldering. On the north-west facing side of the building, the Mission also saw holes in the wall and in the roofing fascia board. At 5 Cherniahovskoho Street, about 200m east of the Culture House, the SMM saw that the roof and the interior of a one-storey uninhabited house were burned down. The Mission assessed the damage to both buildings as fresh and caused by heavy-machine-gun fire. A man and a woman (in their sixties) who introduced themselves as residents of Pikuzy told the Mission that there had been shelling in the area in the previous three days. The man added that as a result the Culture House had caught fire on the evening of 29 August.

On Akhmatovoi Street, near the above-mentioned house, the SMM observed five craters in the asphalt, all located in a straight line from west to east. In three of the craters it saw objects, assessed as the tailfins of mortar rounds. The Mission also saw a crater in the yard of an inhabited house at 50 Akhmatovoi Street, near the craters. The Mission assessed all of the craters as fresh and caused by mortar rounds.

#### Explosion near SMM patrol in Pikuzy

On 1 September, when conducting an impact site assessment on Akhmatovoi Street in the north-eastern part of Pikuzy (see above), the SMM heard and saw an impact explosion 30m south-west of its location after which it saw a tailfin from a rocket-propelled grenade land on the road near the impact. The Mission immediately left Pikuzy and moved to a safe location (see SMM Spot Report 1 September 2019).

#### Stanytsia Luhanska disengagement area

On 31 August and 1 September, inside the disengagement area, the SMM saw up to ten members of the State Security Services (SES) of Ukraine with a bulldozer and a crane continuing to dismantle the former forward position of the Ukrainian Armed Forces north of the Stanytsia Luhanska bridge (15km north of Luhansk) which included removing sand, concrete blocks and metal and wooden debris. On both days, north of the former forward position, the Mission saw up to 20 SES deminers carrying out demining activities west of the road. On 1 September, it saw five SES deminers standing about 50m north of the former forward position.

On 31 August, the SMM saw five members of the armed formations continuing to dismantle the former forward position of the armed formations immediately south of the broken section of the bridge which included removing sand and dirt. The Mission also saw ten members of the armed formations (wearing armbands with "JCCC" written on them) between the southern edge of the broken section of the bridge and the checkpoint of the armed formations south of the bridge.<sup>5</sup>

On the same day, the Mission <u>again</u> observed thick black smoke rising, assessed as caused by burning tyres, from the area of the former forward position of the armed formations.

On 1 September, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) on the southern edge of the broken section of the bridge.

#### Other disengagement areas<sup>6</sup>

On the night of 30-31 August, the SMM camera in Zolote recorded an illumination flare at an assessed range of 2-3km south-east, assessed as inside the disengagement area. On the morning of 31 August, while positioned in Zolote-5/Mykhailivka (non-government-controlled, 58km west of Luhansk), the SMM heard 11 shots of small-arms fire at an assessed distance of 1km north, assessed as outside the disengagement area but within its 5km periphery. On the evening and night of 31 August and 1 September, the SMM camera in Zolote recorded three projectiles in flight at an assessed range of 2-3km east and an illumination flare at an assessed range of 4-5km south-east, all assessed as outside the disengagement area. On the same night, while on the northern edge of Popasna (government-controlled, 69km west of Luhansk), the SMM heard 12 undetermined explosions and about 110 shots and bursts of heavy-machine-gun and small-arms fire, all at an assessed range of 4-6km east-south-east, all assessed as outside the disengagement area near Zolote but within its 5km periphery.

During the day on 31 August and 1 September, positioned close to the disengagement areas near Petrivske (non-government-controlled, 41km south of Donetsk), the Mission observed a calm situation.\*

<sup>5</sup> The Joint Centre for Control and Co-ordination (JCCC) was established in September 2014 by Ukraine and the Russian Federation. Each posted a representative to jointly head the Centre and a staff of officers from the Ukrainian and Russian Federation Armed Forces to be co-located in defined sectors of Luhansk and Donetsk regions. In December 2017, Russian Federation Armed Forces officers withdrew from the JCCC and departed Ukraine.

#### Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In total, the Mission observed six multiple launch rocket systems at the train station in Kostiantynivka (government-controlled, 60km north of Donetsk) and a towed mortar in Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk), both in violation of withdrawal lines. For more details, see the below table of weapons in violation of withdrawal lines as of 1 September 2019.

#### Weapons that the SMM could not verify as withdrawn<sup>7</sup>

Heavy weapons holding areas in government-controlled areas of Donetsk region\* 31 August and 1 September

The SMM noted that an anti-tank gun (MT-12 *Rapira*, 120mm) was present. It also noted that 23 anti-tank guns (11 MT-12 and 12 D48, 85mm), 63 towed howitzers (45 D-20, 152mm, 12 2A36 *Giatsint-B*, 152mm and six D-30 *Lyagushka*, 122mm), 41 self-propelled howitzers (18 2S3 *Akatsiya*, 152mm and 23 2S1 *Gvozdika*, 122mm) and 34 mortars (21 2B11 *Sani*, 120mm, 12 M-120 *Molot*, 120mm and a BM-37, 82mm) were again missing. Four additional anti-tank guns (MT-12) were missing for the first time.

#### Indications of military and military-type presence in the security zone 8

Government-controlled areas

30 August

An SMM mini unmanned aerial vehicle (UAV) spotted an armoured combat vehicle (BTR variant) in Shchastia (20km north of Luhansk).

An SMM long-range UAV spotted:

- an infantry fighting vehicle (IFV) (BMP-1) near Shumy (41km north of Donetsk);
- 11 IFVs (BMP variants) near Dyliivka (52km north of Donetsk);
- an IFV (BTR-4) near Bila Hora (54km north of Donetsk);
- an armoured combat vehicle near Bobrove (56km north-west of Luhansk); and
- two IFVs (BMP variant) near Troitske (69km west of Luhansk).

#### 31 August

The SMM saw an armoured personnel carrier (APC) (BTR-70) near Novobakhmutivka (28km north of Donetsk).

#### 1 September

The SMM saw:

- an IFV (BTR-3) in Nyzhnia Vilkhova (27km north-east of Luhansk) and

- an armoured reconnaissance vehicle (BRDM-2) and two APCs (BTR-70) in Shchastia.

Non-government-controlled areas

#### 30 August

An SMM long-range UAV spotted:

- nine IFVs (BMP variants) and a probable combat engineering vehicle near Kruhlyk (65km south-west of Luhansk);
- an anti-aircraft gun (ZU-23, 23mm) near Kypuche (formerly Artemivsk, 46km west of Luhansk);
- two probable APCs (MT-LB) in Kadiivka (formerly Stakhanov, 50km west of Luhansk); and
- an armoured reconnaissance vehicle (BRDM-2) near Holubivka (formerly Kirovsk, 51km west of Luhansk).

#### Anti-tank mines near Dokuchaievsk

The Mission saw <u>again</u> ten anti-tank mines (TM-62) placed on the road near a checkpoint of the armed formations on the northern edge of Dokuchaievsk (non-government-controlled, 30km south-west of Donetsk).

## SMM facilitation of repair works to civilian infrastructure and of possible demining activities

On 31 August, the SMM monitored adherence to the ceasefire to enable the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk).

On 31 August and 1 September, the Mission continued to facilitate the operation of the DFS and monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

#### Border areas not under government control

On 31 August, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about one hour, the SMM saw 26 cars (nine with Ukrainian, eight with Russian Federation and one with Armenian licence plates, and eight with "DPR" plates), three buses (two with Ukrainian licence plates and one with "DPR" plates), three covered cargo trucks (one with Ukrainian licence plates and two with "DPR" plates) and 23 pedestrians (15 women and seven men, mixed ages) entering Ukraine. During the same time, the Mission saw 20 cars (ten with Russian Federation and one with Lithuanian licence plates, and nine with "DPR" plates), two buses with "DPR" plates, 11 covered cargo trucks (four with Ukrainian licence plates and seven with "DPR" plates) and 21 pedestrians (12 men and nine women, mixed ages) exiting Ukraine.

On the same day, while at a pedestrian border crossing point near Ulianivske (61km southeast of Donetsk) for about 30 minutes, the SMM saw no cross-border traffic.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

## \*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily of 24 August 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

#### Denials of access:

- On 31 August, at a checkpoint 800m north of Zaichenko (non-government-controlled, 26km north-east of Mariupol), two members of the armed formations <u>again</u> denied the SMM passage west to Pikuzy (formerly Kominternove, non-government-controlled, 23km north-east of Mariupol), citing "ongoing demining activities".
- On 31 August, a Ukrainian Armed Forces officer did not allow the Mission to access a part of a heavy weapons holding area in a government-controlled area of Donetsk region.
- On 1 September, at a checkpoint in Lukove (non-government-controlled, 72km south of Donetsk), two members of the armed formations denied the SMM passage, citing "ongoing exercises in the area".
- On 1 September, at a checkpoint in Petrivske (non-government-controlled, 41km south of Donetsk), two members of the armed formations denied the SMM passage, citing "sniper fire in the area". Due to the denial, the Mission was unable to access its camera site in Petrivske.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access to disengagement areas near Zolote and Petrivske, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines and UXO.

#### Delay:

- On 31 August, members of the armed formations allowed the SMM to access its camera site in Petrivske (non-government-controlled, 41km south of Donetsk) after seven minutes.
- On 1 September, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 29km north-east of Mariupol), on two occasions, a member of the armed formations <u>again</u> allowed the SMM to proceed only after about 30 minutes of waiting.

#### Other impediments:

- On the evening and night of 30 August, an SMM long range-UAV lost its GPS signal due to signal interference, assessed as caused by probable jamming, while flying over areas near Stepanivka (government-controlled, 54km north of Donetsk), Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk) and Popasna (government-controlled, 69km west of Luhansk).
- On 31 August, an SMM mid-range UAV experienced signal interference while flying near Lebedynske (government-controlled, 16km north-east of Mariupol), assessed as caused by probable jamming.
- On 31 August, an SMM mini-UAV experienced signal interference while flying near Fedorivka (government-controlled, 32km north-east of Mariupol), assessed as caused by probable jamming.

The SMM is deployed to ten locations throughout Ukraine – Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Donetsk, Dnipro, Chemivtsi, Luhansk and Kyiv – as per Permanent Council Decision 1117 of 21 March 2014. This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs, and forward patrol bases) in Donetsk and Luhansk regions. (In red: a forward patrol base from which SMM staff has temporarily relocated based on recommendations of security experts from participating States as well as SMM security considerations. The SMM uses the premises during daylight hours and patrols in this settlement during daylight hours, as well).
