


Daily Report 234/2019

3 October 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- Inside the Stanytsia Luhanska disengagement area, the SMM continued observing works to a temporary pedestrian bypass to the broken section of the bridge.
- The SMM saw small-arms fire damage to two civilian properties in Staromykhailivka.
- The SMM saw a mortar tailfin inside the disengagement area near Zolote and recorded ceasefire violations near the Zolote and Petrivske disengagement areas.
- The Mission observed a weapon in violation of withdrawal lines in non-government-controlled Donetsk city.
- The SMM saw anti-tank mines near Vesela Hora and Dokuchaievsk.
- The SMM monitored adherence to the ceasefire to facilitate the operation of the Donetsk Filtration Station, electrical repair works in Pikuzy, and repair works to water pipelines between Zolote-3/Stakhanovets and Popasna.
- Restrictions of the Mission's access continued, including at three checkpoints in non-government-controlled areas of Donetsk region and near a border crossing point in a non-government-controlled area of Luhansk region.*
- In Kyiv, the SMM monitored a peaceful protest related to the latest political developments.



In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (about 180), compared with the <u>previous reporting period</u> (about 70 explosions). The majority of ceasefire violations were recorded in areas south of Pyshchevyk (government-controlled, 84km south of Donetsk) (45 per cent), at north-westerly directions of Horlivka (non-government-controlled, 39km north-east of Donetsk), in areas east-north-east of Maiorsk (government-controlled, 45km north-east of Donetsk) and south-west of Svitlodarsk (government-controlled, 57km north-east of Donetsk) with the highest number of explosions (55).

In Luhansk region, the SMM recorded more ceasefire violations, including more explosions (about 70), compared with the <u>previous reporting period</u> (14 explosions). The majority of ceasefire violations were recorded at easterly directions of Popasna (government-controlled, 69km west of Luhansk) where the SMM heard and also saw 57 explosions, assessed as impacts of rounds from undetermined weapons (see below).

Damage to civilian properties related to small-arms fire in Staromykhailivka

At a two-storey building housing a dental clinic at 4 Zhovtneva Street in Staromykhailivka (non-government-controlled, 15km west of Donetsk), the SMM observed a hole in an external, west-facing plastic door frame on the second floor. The SMM also observed a hole in an internal, west-facing aluminium door in a different room on the second floor. In a corridor outside the room, the SMM saw a 3.5cm hole in the ceiling and a 3cm hole in the floor. The SMM assessed all the above damage as fresh and consistent with small-arms fire. At an outhouse at 7 Zhovtneva Street, the SMM saw a 5cm hole in the north-west facing concrete wall, a 5.5cm hole in the east-facing wooden door, as well as scratches to the north-west-facing wall of a residence 3m north-east from the outhouse. The SMM assessed that the damage was fresh and that it was consistent with a projectile. The owners of the residence (a couple in their 50s), as well as the clinic owner (a man in his forties) said that the buildings had sustained the damage on 28 September.

Stanytsia Luhanska disengagement area

On the afternoon of 1 October, the SMM saw workers from government-controlled areas working on the northernmost side of the pedestrian bypass bridge. The SMM observed workers installing seven metal plates and repositioning an additional 16 plates. The SMM also saw that works had been completed on a 1m-wide gravel bed inside the disengagement area on both sides of the asphalt road leading north from the broken section of the bridge to the shelter of an international humanitarian organization.

On the afternoon of 1 October, the SMM saw at least five pedestrians crossing by means of the pedestrian bypass bridge. On 2 October, a Ukrainian Armed Forces officer told the SMM that the pedestrian bypass bridge was complete and that only wooden sideboards remained to be fastened to the bridge. The SMM observed the arrival and installation of wooden side boards on the bypass bridge.

On 1 October, a woman in Luhansk city (non-government-controlled) and a second woman in Sievierodonetsk (government-controlled, 74km north-west of Luhansk) independently told the SMM that they planned to give a video presentation near the broken section of the bridge on the occasion of the International Day of Non-Violence. On 2 October, the SMM observed two women arrive just north of the broken section of the bridge from government-controlled areas who were then joined by two more women and a camera operator (woman) from a TV station in Luhansk city, arriving from non-government-controlled areas. The four women together gave an interview on camera for about an hour. They told the SMM that they called

for a full ceasefire, for strengthening connectivity including the resumption of train services across the line of contact, and the need to increase the number of entry-exit checkpoints with the establishment of safe areas for waiting and access to hygiene facilities and resting points.

Other disengagement areas⁵

Outside the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk) (about 630m north-east of the area's north-east corner), the SMM observed four new mine hazard signs ("Danger Mines" written in Russian) attached to red wooden stakes on both sides of the road from Styla (non-government-controlled, 34km south of Donetsk) to Petrivske. On the same day, positioned in Bohdanivka (government-controlled, 41km southwest of Donetsk), the SMM heard 43 shots and 11 bursts of small-arms fire at an assessed range of 1-2km north-north-west (assessed as outside the Petrivske disengagement area but within 5km of its periphery).*

Inside the disengagement area near Zolote (government-controlled, 60km west of Luhansk), the SMM <u>again</u> observed an exploded 82mm mortar tailfin embedded in the asphalt of road T-1316, about 1.2km south of the area's northern edge. The SMM crossed the road T-1316 through the Zolote disengagement area from non-government- to government-controlled areas and back again. Positioned in Popasna, the SMM heard 11 undetermined explosions and it both heard and saw about 60 explosions assessed as impacts of rounds from undetermined weapons, all at an assessed range of 5-9km east-north-east, east and east-south-east (assessed as outside the Zolote disengagement area but within 5km of its periphery).

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed one weapon in violation of withdrawal lines in non-government-controlled Donetsk city (for more details, see the table below).

Indications of military and military-type presence in the security zone⁶

Government-controlled areas

1 October

An SMM mini-unmanned aerial vehicle spotted:

- two infantry fighting vehicles (IFV) (one BMP-1 and one BMP-1Ksh) near Popasna (69km west of Luhansk) and
- an IFV (BMP variant) near Hranitne (60km south of Donetsk).

The SMM saw an armoured personnel carrier (APC) in Stanytsia Luhanska (16km north-east of Luhansk).

2 October

The SMM saw:

- an IFV (BMP-2) in Popasna and

- an APC (BTR-70) in Raihorodka (34km north-west of Luhansk).

Anti-tank mines near Vesela Hora and Dokuchaievsk and mine hazard sign in Yasne

On 2 October, the SMM <u>again</u> observed anti-tank mines on road H-21 over a 1.1km section of road H-21. Starting about 1.8km north-east of Vesela Hora (non-government-controlled, 16km north of Luhansk) and continuing south, the SMM observed two rows of 11 anti-tank mines (TM-62M) across the eastern lane and nine rows of 53 anti-tank mines (34 TM-57, 15 TM-62P3, and four TM-62M) across the western lane of the dual carriageway, all assessed as belonging to the armed formations.

In the northern outskirts of Dokuchaievsk (non-government-controlled, 30km south-west of Donetsk), on the soft shoulder of the road between Dokuchaievsk and Olenivka (non-government-controlled, 23km south-west of Donetsk), the SMM <u>again</u> saw ten unarmed (safety pins inserted) anti-tank mines (TM62M).

In Yasne (non-government-controlled, 30km south-west of Donetsk), the SMM saw a new mine hazard sign (with "Mines" written in white in Russian) attached to a wooden stake mounted in a concrete block on the asphalt road.

SMM facilitation of operation of and repair works to civilian infrastructure

On 1 October, the SMM monitored adherence to the ceasefire to facilitate electrical repair works in Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk).

On 2 October, the SMM monitored adherence to the ceasefire to facilitate repairs to water pipelines between Zolote-3/Stakhanovets (government-controlled, 61km west of Luhansk) and Popasna. It continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk).

Border areas not under government control

While at a border crossing point near Dovzhanske (84km south-east of Luhansk) for about 20 minutes, the SMM saw 17 trucks (with Ukrainian licence plates) and three pedestrians entering Ukraine. It also saw six cars (five with Ukrainian licence plates, one with "LPR" plates), 17 covered cargo trucks (11 with Ukrainian and one with Azerbaijani licence plates, five with "LPR" plates), and five pedestrians exiting Ukraine.

While at a border crossing point near Novoborovytsi (79km south of Luhansk) for about 15 minutes, the SMM did not observe any vehicular or pedestrian traffic in either direction.

Peaceful protest in Kyiv

At Independence Square in Kyiv, the SMM monitored a peaceful protest of 3,000-3,500 people (mixed genders and age) expressing messages critical of recent political developments concerning certain areas of Donetsk and Luhansk regions.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary

from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a border crossing point near Dovzhanske (non-government-controlled, 84km south-east of Luhansk), an armed member of the armed formations told the SMM to leave the area.
- At a checkpoint on the northern edge of Petrivske (non-government-controlled, 41km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage citing "ongoing demining activities", thereby restricting the SMM's access to its camera in Petrivske.
- In Yasne (non-government-controlled, 30km south-west of Donetsk), three armed members of the armed formations denied the SMM passage, citing "ongoing mine clearing" in the area.
- At a checkpoint of the armed formations about 600m west of Verkhnoshyrokivske (non-government-controlled, 85km south of Donetsk), two armed members of the armed formations denied the SMM passage, citing "anti-terrorist activities in the area".
- At a checkpoint of the armed formations at the eastern entrance of Shevchenko (non-government-controlled, 69km south of Donetsk), two armed members of the armed formations denied the SMM passage, citing "kinetic activities in the area" and "concern for the SMM's safety".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Conditional access:

- At a checkpoint in Staromykhailivka (non-government-controlled, 15km west of Donetsk), three members of the armed formations denied the SMM passage for 98 minutes at which point the SMM was allowed to pass with an escort car from the armed formations for the duration of its presence in Staromykhailivka.


