

Daily Report 259/2019

1 November 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded fewer ceasefire violations in Donetsk region. It recorded no ceasefire violations in Luhansk region.
- The SMM saw a crater in the yard of a residential house in Zolote-5/Mykhailivka.
- The SMM observed further withdrawal of forces and hardware from the Zolote disengagement area.
- Inside the Stanytsia Luhanska disengagement area, the Mission continued to observe construction works at the broken section of the bridge.
- The Mission recorded no violations inside all three disengagement areas.
- The SMM observed two weapons in violation of withdrawal lines in government-controlled and non-government-controlled areas of Donetsk region.
- The Mission observed two convoys consisting of trucks with Russian Federation licence plates in non-government-controlled of Donetsk city and Luhansk city.
- The SMM continued to observe long queues of civilians travelling across the contact line in Donetsk region.
- The SMM monitored adherence to the ceasefire to facilitate the operation of and repairs to critical civilian infrastructure on both sides of the contact line.
- Restrictions of the SMM's freedom of movement continued, including at checkpoints near non-government-controlled Zaichenko and Novoazovsk.*



In Donetsk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 40), compared with the <u>previous reporting period</u> (about 60 explosions). The majority of ceasefire violations, were recorded at southerly directions of Pyshchevyk (government-controlled, 84km south of Donetsk) and in areas west and west-north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk).

In Luhansk region, the Mission recorded no ceasefire violations. In the <u>previous reporting</u> <u>period</u>, it had recorded two explosions.

Crater in a residential area of Zolote-5/Mykhailivka

On 2 Kutuzova Street in the western part of Zolote-5/Mykhailivka (non-government-controlled, 58km north-west of Luhansk), about 80m south of the most forward position of the armed formations, the Mission saw a crater (about 1.5m in diameter) in a yard about 5m north of a one-storey inhabited house. The Mission assessed the crater as fresh; however it could not assess the type of weapon used or direction of fire.

Disengagement process at the Zolote disengagement area⁵

On 31 October, the SMM continued to observe withdrawal of forces and hardware from the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk) (see the SMM Spot Report 29 October 2019).

Between 11:50 and 12:42, while positioned at the checkpoint of the Ukrainian Armed Forces on the northern edge of the disengagement area, the SMM saw two trucks arriving from the direction of Katerynivka (government-controlled, 64km west of Luhansk), inside the disengagement area, to the checkpoint of the Ukrainian Armed Forces about 300m north of the disengagement area. Positioned in the same location, the SMM also saw five military trucks arriving from the direction of Zolote-4/Rodina (government-controlled, 61km west of Luhansk) to the aforementioned checkpoint. It saw in total 21 Ukrainian Armed Forces personnel (armed with AK-type assault rifles) disembarking the trucks at the aforesaid checkpoint.

On the same day, inside the disengagement area, the Mission also observed two paint marks across road T-1316 (parallel lines in red and white colours) about 80m south of the disengagement area's northern edge.

On the afternoon of the same day, positioned at the checkpoint of the armed formations on the southern edge of the disengagement area, the SMM saw a truck with two blue containers (with "JCCC" written on them in Russian), which were placed on the western side of road T-1316 about 20-30m south of the aforementioned checkpoint, outside the disengagement area.

On 30 October, inside the disengagement area, an SMM mini-unmanned aerial vehicle (UAV) spotted six persons, assessed as Ukrainian Armed Forces personnel, and a truck in Katerynivka about 450m south of the area's southern edge and about 1.3km east of its western edge. At 12:14, about 500m further north-east, also in Katerynivka, the UAV spotted six persons in a truck and one standing next to it, assessed as Ukrainian Armed Forces personnel. About ten minutes later, the UAV spotted the same truck driving from

Katerynivka, inside the disengagement area, to a location outside the disengagement area, just north of the checkpoint of the Ukrainian Armed Forces on its northern edge.

On the same day, inside the disengagement area, about 35m east of road T-1316 and about 60m south of the disengagement area's northern edge, an SMM mini-UAV spotted three trucks and about 12 persons, assessed as Ukrainian Armed Forces personnel, installing an about 165m-long barbed wire barrier running from west to east. The UAV also spotted them installing another 250m-long barbed wire barrier about 25m east of the first one's end running from south-east to north-east, starting from inside the disengagement area and extending about 180m outside of it (for previous observations in the area, see SMM Daily Report 31 October 2019).

On the same day, inside the disengagement area, the same UAV spotted two persons, assessed as members of the armed formations, about 950m north of the area's southern edge and 850m west of its eastern edge. The UAV also spotted a green civilian vehicle inside the positions of the armed formations about 150m north of its southern edge and about 800m west of its eastern edge (for recent observations, see SMM Daily Report 31 October 2019).

Disengagement areas near Stanytsia Luhanska and Petrivske

On 31 October, inside **the disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM saw 11 workers from government-controlled areas clearing vegetation on the western side of the road near a shelter of an international humanitarian organization north of the Stanytsia Luhanska bridge (15km north-east of Luhansk); 15 workers working on two main support pillars of the bridge as well as removing mould pieces of the abutment for the deck of the bridge and welding anchor points for the metal beams; ten workers welding parts of a pillar at the southern edge of the broken section of the bridge; and a bulldozer clearing the area and loading debris into a truck in an area west of the southern part of the broken section of the bridge. The Mission also saw a loader removing sand bags and tyres from the area under the broken section of the bridge, following the <u>removal</u> of sand-filled tyres and of a blue container, as well as a truck driving and disembarking iron railings at the metal section of bridge.

It also observed seven workers from non-government-controlled areas clearing vegetation west of the road near a shelter of an international humanitarian organization south of the checkpoint of the armed formations; six workers burning vegetation about 20m south-west of the aforementioned shelter; and 11 workers laying asphalt and gravel at the parking lot south-east of the checkpoint of the armed formations south of the bridge. The SMM also saw five members of the armed formations (wearing armbands with "JCCC" written on them) between the broken section of the bridge and the checkpoint of the armed formations south of the bridge.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed two weapons in violation of withdrawal lines in government-controlled and non-government-controlled areas of Donetsk region. It also observed two weapons beyond withdrawal lines but outside of designated storage in government-controlled areas of Donetsk region (for further details, see the tables below).

Weapons that the SMM could not verify as withdrawn⁶

At a two heavy weapons holding areas in a government-controlled area of Luhansk region 31 October

The SMM noted that:

- ten self-propelled howitzers (2S1 *Gvozdika*, 122mm) were present;
- two mortars (M120-15 *Molot*, 120mm) were seen for the first time; and
- 25 self-propelled howitzers (23 2S3 *Akatsiya*, 152mm and two 2S1) and 15 towed howitzers (D-30 *Lyagushka*, 122 mm) continued to be missing.

Indications of military and military-type presence in the security zone⁷

The SMM observed military and military-type presence inside the security zone on both sides of the contact line in Donetsk and Luhansk regions, including two armoured personnel carriers in a residential area of Novhorodske (government-controlled, 35km north of Donetsk) (for further details, see the table below)).

Presence of anti-tank mines near government-controlled Troitske and unexploded ordnance (UXO) between government-controlled Tonenke and Vodiane

On 30 October, an SMM mini-UAV <u>again</u> spotted about 35 anti-tank mines (part of a previously observed minefield comprising 150 anti-tank mines about 3km east of Troitske (government-controlled, 30km north of Donetsk).

On 31 October, the SMM <u>again</u> saw six metal objects, assessed as UXO, embedded in asphalt roads C051802 and C051803 between Tonenke (government-controlled, 19km north-west of Donetsk) and Vodiane (government-controlled, 15km north-west of Donetsk), out of which four were assessed as fragments of 122mm rockets and two as fragments of artillery shells.

Two convoys consisting of trucks with Russian Federation licence plates in non-government-controlled of Donetsk city and Luhansk city

On the morning of 31 October, the SMM observed a convoy of 20 trucks with Russian Federation licence plates (with "Humanitarian Aid from the Russian Federation" written in Russian on two of them) accompanied by five vehicles with "DPR" plates entering a walled compound at 1a Baumana Street in Donetsk city's Budonivskyi District. The SMM saw 15 workers from the non-government-controlled areas unloading the content of the trucks.

On the same day, the SMM saw a convoy of 12 trucks with Russian Federation licence plates (with "Humanitarian Aid from the Russian Federation" written in Russian on four of them) accompanied by four vehicles with "LPR" plates entering a walled compound at Darhomyzhskoho Street in the southern part of non-government-controlled Luhansk city (for previous observations in the area, see <u>SMM Daily Report 18 October 2019</u>).

Situation at checkpoints along the contact line

The SMM continues to see long queues at the entry-exit checkpoints (EECPs) of the Ukrainian Armed Forces and at checkpoints of the armed formations along the contact line. At a checkpoint on highway H-15 in Kreminets (non-government-controlled, 16km southwest of Donetsk), the SMM saw about 220 cars and 40 pedestrians queuing to enter government-controlled areas and about 80 cars and four buses in a queue in the opposite direction.

SMM facilitation of repairs to civilian infrastructure

The Mission continued to monitor adherence to the ceasefire to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and maintenance of the Phenol Sludge Reservoir near Zalizne (formerly Artemove, government-controlled, 42km north-east of Donetsk).

Border areas not under government control

While at a border crossing point near Izvaryne (52km south-east of Luhansk) for about 30 minutes, the SMM saw three cars with Ukrainian licence plates entering Ukraine.

While at a pedestrian border crossing point near Verkhnoharasymivka (57km south-east of Luhansk) for about 30 minutes, the SMM saw eight pedestrians (two women and six men) entering Ukraine.

The SMM continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 26 October 2019). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint north of Zaichenko (non-government-controlled, 93km south of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage towards Sakhanka (non-government-controlled, 97km south of Donetsk), citing "ongoing demining activities".
- At a checkpoint on the northern edge of Novoazovsk (non-government-controlled, 102km south-east of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM access south towards Novoazovsk, citing "orders from superiors".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), two members of the armed formations (one of them visibly armed) allowed the SMM to proceed only after 23 minutes of waiting.

Other impediments:

- An SMM mini-UAV experienced signal interference, assessed as due to probable jamming, while flying near Viktorivka (non-government-controlled, 42km south-west of Donetsk).⁸


