

OSCCE Special Monitoring Mission to Ukraine

Daily Report 44/2020

22 February 2020¹

Summary

- Compared with the previous reporting period, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- The Mission followed up on reports of a man injured by shrapnel from shelling in non-• government-controlled Holubivske on 18 February.
- The SMM saw fresh craters in Popasna and near Verkhnoshyrokivske as well as recent • impacts inside the Donetsk Filtration Station.
- It continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and • Petrivske.
- It facilitated localized ceasefires to enable repairs to critical civilian infrastructure. •
- The SMM's freedom of movement continued to be restricted, including at checkpoints • of the armed formations near Verkhnoshyrokivske, Kovske and Siedove.*



In Donetsk region, the SMM recorded more ceasefire violations, including more explosions (195), compared with the <u>previous reporting period</u> (90 explosions). Two thirds of the ceasefire violations, including the majority of explosions, were recorded in areas south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk) as well as north and north-north-east of Shyrokyne (government-controlled, 100km south of Donetsk).

In Luhansk region, the Mission recorded more ceasefire violations, including more explosions (95), compared with the <u>previous reporting period</u> (27 explosions). As in the previous reporting period, more than half of the ceasefire violations, including the majority of explosions, were recorded in areas north and north-east of Berezivske (non-government-controlled, 53km north-west of Luhansk).

Man injured by shrapnel in Holubivske

On 20 February, in the southern part of Holubivske (non-government-controlled, 51km west of Luhansk), at 19/2 Przhevalskoho Street, the SMM saw a man (55 years old) with injuries to his hip which he said he had sustained during shelling in the morning of 18 February while he had been in his house. On 21 February, at the hospital in Holubivka (formerly Kirovsk, non-government-controlled, 51km west of Luhansk), medical staff told the SMM that the man had been admitted on 18 February with shrapnel-related injuries to his hip incurred on that day, and had been released on the same day after receiving medical treatment. (The SMM reported damage from shelling at Przhevalskoho Street in Holubivske, see <u>SMM daily report 21 February 2020.</u>)

Recent impacts inside the Donetsk Filtration Station and fresh craters in Popasna and near Verkhnoshyrokivske

On 20 February, an SMM mini-unmanned aerial vehicle (UAV) spotted about 25 craters, assessed as recent impacts (unable to determine the weapon type or direction of fire), inside the Donetsk Filtration Station (DFS) area, in the courtyards north and south of the main building and near the chlorine warehouse. The SMM did not observe any visible outside damage caused to the DFS by the impacts.

On 21 February, the SMM saw three fresh craters about 10m apart assessed as caused by 152mm artillery rounds fired from an easterly direction, the first one on the eastern edge of the road and the two others about 5m west of the road, about 15m from a military compound of the Ukrainian Armed Forces on the north-eastern edge of Popasna (government-controlled, 69km west of Luhansk), about 600m east of a residential area. On the same day, an SMM mini-UAV spotted a crater inside the aforesaid compound and another one in a field about 50m further north. The UAV also spotted about eight craters in an adjacent cemetery about 50m west of the same compound. All of the aforesaid craters were assessed as fresh. The Mission was unable to assess the type of weapon used or direction of fire.

On the same day, the SMM saw two fresh craters assessed as caused by 82mm mortar rounds (unable to determine the direction of fire) near the most forward positions of the armed formations, one on the shoulder of the road between the entry-exit checkpoint in Hnutove (government-controlled, 90km south of Donetsk) and the corresponding checkpoint of the armed formations in Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk) and the other one, nearby, in a field 10m north of the road.

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁴

On 21 February, inside the **disengagement area near Stanytsia Luhanska** (governmentcontrolled, 16km north-east of Luhansk), the SMM saw six members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

On 20 February, the SMM camera in Zolote (government-controlled, 60km west of Luhansk) recorded 14 undetermined explosions, eight projectiles in flight and two illumination flares at an assessed range of 3-6km east, all assessed as outside the **Zolote disengagement area** but within 5km of its periphery. On 21 February, while positioned in five locations near the disengagement area, the SMM heard 35 undetermined explosions, all assessed as outside the area but within 5km of its periphery.

On the evening of 20 February, the SMM camera in Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded 17 projectiles in flight, the majority from north-north-east to south-south-west, at an assessed range of 1-3km east-south-east and assessed as inside **the disengagement area near Petrivske**.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission saw a weapon in violation of withdrawal lines in government-controlled Donetsk region. It saw two weapons beyond withdrawal lines but outside designated storage sites in a government-controlled area of Donetsk region (see the table below).

Weapons that the SMM could not verify as withdrawn⁵

At six heavy weapons holding areas in government-controlled areas of Donetsk region 20 February

The Mission noted that 12 towed howitzers (2A65 *Msta-B*, 152mm), 22 self-propelled mortars (2S9 *Nona-S*, 120mm) and four towed mortars (2B9 *Vasilek*, 82mm) continued to be missing.

Weapons permanent storage sites

At a permanent storage site in a government-controlled area of Donetsk region 21 February

The Mission noted that 81 tanks (48 T-64 and 33 T-72), nine mortars (M120-15 *Molot*, 120mm) and 12 anti-tank guns (MT-12 *Rapira*, 100mm) continued to be missing. Three mortars (M120-15), 28 tanks (16 T-64 and 12 T-72) and six anti-tank guns (MT-12) were missing for the first time.

The SMM noted that two such sites continued to be abandoned.

Indications of military and military-type presence in the security zone⁶

The SMM observed armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions and in an area of non-government-controlled Donetsk region (for further details, see the table below).

Long queues at checkpoints along the contact line

In the morning of 21 February, at the checkpoint of the armed formations near Kreminets (nongovernment-controlled, 16km south-west of Donetsk), the SMM saw about 150 cars queuing to travel towards government-controlled areas and about 20 cars and a mini-bus queuing in the opposite direction. In the early afternoon of the same day, at the checkpoint near Olenivka (nongovernment-controlled, 23km south-west of Donetsk), the Mission saw about 200 cars queuing to travel towards government-controlled areas and 25 cars queuing in the opposite direction.

SMM facilitation of repairs and the operation of critical civilian infrastructure

The SMM facilitated and monitored adherence to localized ceasefires to enable repairs to water pipelines near Zalizne (government-controlled, 42km north-east of Donetsk) as well as to the power lines between Berezivske (non-government-controlled, 53km north-west of Luhansk) and Donetskyi (non-government-controlled, 49km west of Luhansk) and between Donetskyi and Holubivske.

The Mission continued to facilitate the maintenance and operation of DFS (15km north of Donetsk) and monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk). While positioned in two locations near the DFS, the SMM heard two undetermined explosions and 22 shots and bursts of heavy-machine-gun and small-arms fire, less than 3km from the DFS.

The SMM monitored a protest related to events at Maidan in 2014 in Kyiv

In the evening of 20 February, in front of the building of the presidential administration at 11 Bankova Street in Kyiv, the Mission saw about 4,000 people (mixed ages and genders), some of whom were holding flags of the National Corps, Svoboda and "Democratic Axe". Participants expressed messages critical of political developments concerning certain areas of Donetsk and Luhansk regions. The protest was held on the same day of the commemoration of Maidan-related events in 2014. The SMM saw about 20 Dialogue Police officers. No incidents were observed.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, and Chernivtsi.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these

violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see <u>SMM Daily Report 19 February 2020</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following <u>the fatal incident of 23 April 2017</u> <u>near Pryshyb</u>; these restrictions continued to limit the Mission's observations.

Denials of access:

- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-governmentcontrolled, 85km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas, citing "ongoing operation in the area". While at the checkpoint, the Mission saw cars passing through it in both directions.
- At a checkpoint near Kovske (non-government-controlled, 91km south of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage towards Samiilove (non-government-controlled, 89km south of Donetsk), citing "military exercises in the area".
- At a checkpoint near Siedove (non-government-controlled, 106km south of Donetsk), two armed members of the armed formations <u>again</u> denied the SMM passage towards the settlement, citing "orders from superiors".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilian movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr), an armed member of the armed formations allowed the SMM passage towards non-government-controlled areas after about 20 minutes of waiting.

Other impediments:

- An SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Zernove (non-government-controlled, 70km south of Donetsk).⁷


