

Daily Report 77/2020

1 April 2020¹

Summary


- Compared with the previous reporting period, the SMM recorded fewer ceasefire violations in both Donetsk and Luhansk regions.
- Small-arms fire was assessed as aimed at SMM mini-unmanned aerial vehicles flying over areas near government-controlled Hnutove and near non-governmentcontrolled Molodetske.
- Members of the armed formations continued to deny the SMM passage towards nongovernment-controlled areas of Luhansk region at a checkpoint south of Stanytsia Luhanska bridge.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske.
- The SMM again saw that three entry-exit checkpoints of the Ukrainian Armed Forces and a checkpoint of the armed formations in Donetsk and Luhansk regions remained closed amid the COVID-19 outbreak.
- The Mission facilitated the operation of the Donetsk Filtration Station. It recorded ceasefire violations within a 2km radius of the station, including during a transit by bus of *Voda Donbassa* employees.
- The SMM monitored adherence to localized ceasefires to enable demining in cemeteries in a government-controlled area of Luhansk region and construction and repairs of critical civilian infrastructure in Luhansk and Donetsk regions.

Number of recorded explosions⁴



In Donetsk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 125), compared with the <u>previous reporting period</u> (about 405 explosions). The majority of ceasefire violations were recorded at westerly directions of Horlivka (non-government-controlled, 39km north-east of Donetsk), in areas close to the Donetsk Filtration Station (DFS) (15km north of Donetsk), and at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk).

In Luhansk region, the SMM recorded fewer ceasefire violations, including fewer explosions (about 20), compared with the <u>previous reporting period</u> (34 explosions). The majority of ceasefire violations were recorded at easterly directions of Zolote (government-controlled, 60km west of Luhansk) and in areas north-west of Krasnyi Lyman (non-government-controlled, 30km north-west of Luhansk) (see below).

Small-arms fire assessed as directed at SMM UAVs near government-controlled Hnutove and non-government-controlled Molodetske

While conducting a mini-unmanned aerial vehicle (UAV) flight over areas near Hnutove (government-controlled, 90km south of Donetsk), the SMM heard three bursts of small-arms fire at an assessed distance of 3km east, assessed as targeting the UAV, which was flying 3km east of the patrol's position.*

While conducting a mini-UAV flight over areas near Molodetske (non-government-controlled, 50km east of Donetsk), the SMM heard 30 shots of small-arms fire at an assessed range of 600-700 meters south-east, assessed as targeting the UAV, which was flying at an assessed range of 600-700 meters south-east of the patrol's position.*

In both cases, the Mission landed its UAV safely and left the area.

Members of the armed formations continued to deny SMM passage at a checkpoint in **Luhansk region**

Members of the armed formations continued to deny the Mission passage at a checkpoint south of Stanytsia Luhanska bridge (15km north-east of Luhansk) along an official crossing route. These restrictions constitute an impediment to the implementation of the Mission's mandate.⁵*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁶

On 31 March, positioned inside the **disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), the SMM observed a calm situation. Throughout the day, the SMM observed four members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and their checkpoint south of it.

During the evening of 30 March, the SMM camera in Zolote recorded five undetermined explosions, ten projectiles in flight and an illumination flare, all at an assessed range of 2-

3km east and east-north-east and assessed as outside **the disengagement area near Zolote** but within 5km of its periphery. During the day on 31 March, the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On 30 March, an SMM mini-UAV spotted at least 110 anti-tank mines about 100-200m north and west of the northern and western edges, respectively, **of the disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), all in fields north and south of a road between Petrivske and Bohdanivka (government-controlled, 41km southwest of Donetsk) and assessed as belonging to the Ukrainian Armed Forces. It also spotted 16 anti-tank mines, placed in a cluster following demining activities, in a field about 100m north of the northern edge of the disengagement area, assessed as belonging to the armed formations. (For previous observations in the area, see SMM Daily Report 24 March 2020).

Outside the disengagement area, about 600m south of it, the same UAV also spotted an armored combat vehicle and a person assessed as Ukrainian Armed Forces personnel.

During the day on 31 March, while positioned about 2km east of Bohdanivka, the SMM heard 21 shots of small-arms fire at an assessed range of 2-3km north-west and assessed as outside the disengagement area but within 5km of its periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

Indications of military and military-type presence in the security zone⁷

The Mission observed an armoured combat vehicle and an infantry fighting vehicle in government-controlled areas in Donetsk region (for further details, see the table below).

On a pedestrian bridge 2km east of Staryi Aidar (government-controlled, 20km north-west of Luhansk), the SMM observed for the first time a mine hazard sign with "Stop Mine!" written in Ukrainian and "Danger Mines!" written in English.

Measures at checkpoints along the contact line to counter COVID-19 outbreak

In Donetsk region, the SMM noted that the entry-exit checkpoints (EECP) near Hnutove and Maiorsk (government-controlled, 45km north-east of Donetsk) remained closed due to the COVID-19 outbreak.

In Luhansk region, the Mission noted that the EECP near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge also remained closed due to the COVID-19 outbreak. At the EECP, it <u>again</u> saw about 45 people (mostly women of mixed ages, as well as two children), reportedly waiting to travel towards non-government-controlled areas. At a checkpoint 200m south of Stanytsia Luhanska bridge, two members of the armed formations separately told the SMM that they

were not aware of the civilians waiting at the aforementioned EECP to travel towards non-government-controlled areas and that "they were under strict orders not to let anybody, including civilians with residency "permits" and the SMM, pass through their checkpoint".*

All EECPs have been closed since 22 March. The corresponding checkpoints of the armed formations in Donetsk and Luhansk regions (including the one south of the Stanytsia Luhanska bridge) have been closed since 21 March and 23 March, respectively.

SMM facilitation of the operation, construction and repairs of critical infrastructure and of demining activities near cemeteries

The SMM facilitated and monitored adherence to localized ceasefires to enable construction of power lines close to the EECP near Maiorsk and repairs to water infrastructure in Krasnyi Lyman, as well as to enable demining activities in two cemeteries each in Katerynivka (government-controlled, 64km west of Luhansk) and Zolote-4/Rodina (government-controlled, 59km west of Luhansk).

The Mission also continued to facilitate the operation of the DFS. On the evening of 30 March, the SMM camera at the DFS recorded two undetermined explosions at an assessed range of 0.5-1km south and a projectile in flight at an assessed range of 2-4km east. During the day on 31 March, while positioned near the DFS, the SMM heard 27 bursts of heavy-machine-gun fire occurring while a bus was transporting *Voda Donbassa* employees from the DFS. Additionally, throughout the day, while positioned in four locations near the DFS, it also heard about 30 undetermined explosions and about 140 bursts and shots of heavy-machine-gun and small-arms fire, all assessed as within a 2km radius of the DFS.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example see SMM Daily Report 28 March 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint 200m south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), a member of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas of Luhansk region, citing "orders from superiors".

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Conditional access:

- At the boundary line between Luhansk and Donetsk regions near Debaltseve (non-government-controlled, 58km north-east of Donetsk), a member of the armed formations only allowed the SMM to proceed toward non-government-controlled areas of Donetsk region after being shown patrol members' health certificates and checking their temperatures.
- At a checkpoint about 1km south-east of Zelenopillia (government-controlled, 70km north of Donetsk), a police officer only allowed the SMM to proceed after its cars had undergone disinfection procedures. Two police officers explained that vehicles passing the checkpoint needed to undergo disinfection as a preventative measure against COVID-19.

Other impediments:

- While conducting a mini-UAV flight near Hnutove (government-controlled, 90km south of Donetsk), the SMM heard three bursts of small-arms fire assessed as directed at its UAV (see above).
- While conducting a mini-UAV flight near Molodetske (non-government-controlled, 50km east of Donetsk), the SMM heard 30 shots of small-arms fire assessed as directed at its UAV (see above).


