

Daily Report 81/2020


6 April 2020¹

Summary

- Compared with the previous reporting period, between the evenings of 3 and 4 April, the SMM recorded more ceasefire violations in Donetsk region and fewer in Luhansk region.
- Between the evenings of 4 and 5 April, the Mission recorded fewer ceasefire violations in both Donetsk and Luhansk regions, compared with the previous 24 hours.
- Small-arms and heavy-machine-gun fire were assessed as directed at SMM miniunmanned aerial vehicles flying over areas near Taramchuk and Berezove in Donetsk region, and Holubivske in Luhansk region.
- A woman sustained shrapnel injuries in Verkhnotoretske.
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske, and spotted a person walking inside the disengagement area near Zolote.
- The Mission saw weapons in violation of withdrawal lines in non-governmentcontrolled areas of Donetsk region.
- The SMM monitored and facilitated adherence to localized ceasefires to enable maintenance of railway tracks near government-controlled Vilkhove, as well as demining activities in non-government-controlled Krasnyi Yar.
- The Mission again saw that two entry-exit checkpoints and their corresponding checkpoints in both Donetsk and Luhansk regions remained closed amid the COVID-19 outbreak.
- The SMM's freedom of movement continued to be restricted in both Donetsk and Luhansk region.

Ceasefire violations²





In Donetsk region, between the evenings of 3 and 4 April, the SMM recorded more ceasefire violations, including more explosions (about 120), compared with the <u>previous reporting period</u> (60 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at westerly and northerly directions of non-government-controlled Donetsk city, at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk), at easterly directions of Avdiivka (government-controlled, 17km north of Donetsk) and at southerly and westerly directions of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

Between the evenings of 4 and 5 April, the Mission recorded fewer ceasefire violations, including fewer explosions (about 65), compared with the previous 24 hours. The majority of ceasefire violations were recorded at southerly directions of Svitlodarsk, at northerly directions of Shyrokyne and in areas north-west of Donetsk city.

In Luhansk region, between the evenings of 3 and 4 April, the SMM recorded fewer ceasefire violations, including fewer explosions (about 90), compared with the <u>previous reporting period</u> (about 160 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded at northerly, southerly and westerly directions of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below).

Between the evenings of 4 and 5 April, the Mission recorded fewer ceasefire violations, including fewer explosions (about 20), compared with the previous 24 hours. The majority of ceasefire violations, including the majority of explosions, were recorded at easterly directions of the disengagement area near Zolote (see below).

Small-arms and heavy-machine-gun fire assessed as directed at three SMM miniunmanned aerial vehicles

On 5 April, while positioned about 1km north-east of Berezove (government-controlled, 31km south-west of Donetsk) to conduct a mini-unmanned aerial vehicle (UAV) flight over areas near Taramchuk (government-controlled, 29km south-west of Donetsk), the SMM heard six bursts of small-arms and heavy machine-gun fire at an assessed distance of about 3km north-north-west of its position, assessed as directed at the UAV, which was flying 3km north-north-west of the patrol's position. The Mission landed its UAV safely.*

While positioned at the same location to conduct another mini-UAV flight over areas near Berezove, the SMM heard 18 bursts of small-arms fire at an assessed distance of about 2km south-east of its position, assessed as directed at the UAV, which was flying about 2km south-east of the patrol's position. The Mission landed its UAV safely and left the area.*

While positioned in Holubivske (non-government-controlled, 51km west of Luhansk) to conduct a mini-UAV flight over areas near Holubivske, the SMM heard ten shots of small-arms fire at an assessed range of 1-2km north-north-east of its position, assessed as directed at the UAV, which was flying about 1km north-north-east of the patrol's position. The Mission landed its UAV safely and left the area.*

Woman sustained shrapnel wounds in Verkhnotoretske

On 5 April, medical personnel at a hospital in Toretsk (formerly Dzerzhynsk, government-controlled, 43km north of Donetsk) told the SMM by phone that on the evening of 4 April, a woman (aged 68) with shrapnel wounds in one of her legs had been brought in from Verkhnotoretske (government-controlled, 23km north-east of Donetsk). On 5 April, the

woman told the SMM by phone that on the afternoon of 4 April, she had been in the yard of her house in Verkhnotoretske when she heard shooting and explosions nearby. She added that shortly thereafter, she had felt pain in her lower left leg.

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

On 4 April, the SMM saw police and representatives of the State Emergency Service of Ukraine carrying out demining activities near the entry-exit checkpoint (EECP) in Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), about 1km north of Stanytsia Luhanska bridge (15km north-east of Luhansk), reportedly to remove remnants of ammunition from World War II.

On 5 April, positioned inside the **disengagement area near Stanytsia Luhanska**, the SMM heard three shots of small-arms fire at an assessed range of 3-5km north-north-east, assessed as outside the disengagement area but within 5km of its periphery. On 5 April, inside the disengagement area, the Mission saw two members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it.

In the early morning hours of 3 April, inside the **disengagement areanear Zolote**, an SMM long-range UAV spotted a person heading south along a track near the area's northern edge, close to a former position of the Ukrainian Armed Forces. On 4 and 5 April, the SMM saw members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area.

On the evening of 3 April, the SMM camera in Zolote recorded five undetermined explosions. Between the night of 4 April and morning of 5 April, the camera recorded five projectiles in flight at an assessed range of 1-5km east and east-south-east (all assessed as outside the disengagement area but within 5km of its periphery). On 4 April, while positioned at six locations near the disengagement area near Zolote, the SMM heard 74 undetermined explosions and 21 bursts of heavy-machine-gun and automatic grenade launcher fire. On 5 April, while positioned at three locations near the disengagement area, the Mission heard 13 explosions. All these ceasefire violations were assessed as outside the disengagement area but within 5km of its periphery.

On 4 April, while positioned about 2km north-north-east of the **disengagement area near Petrivske** (non-government controlled, 41km south of Donetsk) the SMM heard an undetermined explosion at an assessed range of 4-6km east of its position, assessed as outside the disengagement area. On the same day, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over the disengagement area.*On 5 April, while positioned near the disengagement area, the Mission noted a calm situation.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission saw a surface-to-air missile system and eight tanks in non-government-controlled areas of Donetsk region, in violation of their respective withdrawal lines (for further details, see the tables below).

Indications of military and military-type presence inside the security zone⁶

The SMM observed military and military-type presence in the security zone on both sides of the contact line, including within residential areas (for further details, see the table below).

SMM facilitation of operation and maintenance of critical civilian infrastructure and demining activities

On 4 and 5 April, the SMM facilitated and monitored adherence to localized ceasefires to enable vegetation clearance and the inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk), and, on 4 April, to enable demining activities in Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk). On 4 April, while positioned near the disengagement area near Stanytsia Luhanska, the SMM heard an undetermined explosion at an assessed range of 5-7km north-west of its position, assessed as a controlled detonation related to demining in Krasnyi Yar.

On 4 and 5 April, the Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS). On 4 April, while positioned near the DFS, and during the transit of a bus transporting *Voda Donbassa* employees to the DFS, the SMM heard about 200 shots and bursts of small-arms and heavy machine-gun fire and about ten undetermined explosions. On 5 April, while positioned near the DFS, the SMM heard an undetermined explosion and five shots and bursts of small-arms and heavy-machine-gun fire. All of these ceasefire violations were assessed as within a 3km radius of the DFS.

Measures at entry-exit checkpoints and corresponding checkpoints to counter COVID-19 outbreak

In Donetsk region on 5 April, the SMM noted that the EECP near Novotroitske (government-controlled, 36km south-west of Donetsk) remained closed. On 4 and 5 April, it noted that the corresponding checkpoint of the armed formations near Olenivka (non-government-controlled, 23km south-west of Donetsk) remained closed.

In Luhansk region on 4 and 5 April, the SMM saw that the EECP in Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed. On 4 April, the Mission saw 31 people (mixed ages and genders) at the EECP, reportedly waiting to travel towards non-government-controlled areas, and on 5 April it saw 14 people (mixed ages and genders) waiting to travel towards non-government-controlled areas.

On 3 April, a woman told the SMM by phone that she and her husband had been unable to pass through the EECP in Stanytsia Luhanska to attend her father's funeral in a non-government-controlled area. Another woman told the Mission by phone that she had been unable to pass through the same EECP to see her ill husband in a non-government-controlled area.

On 4 April, on road P-66, at a checkpoint on the southern edge of Lysychansk (government-controlled, 75km north-west of Luhansk), two police officers stopped an SMM vehicle and disinfected its tires for about two minutes.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Coordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example see SMM Daily Report 28 March 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- On 4 April, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over the disengagement area near Petrivske (non-government controlled, 41km south of Donetsk).⁷
- On the same day, on two occasions, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Oktiabr mine (non-government controlled, 9km north-west of Donetsk).8
- On 5 April, while conducting a mini-UAV flight near Taramchuk (government-controlled, 29km south-west of Donetsk), the SMM heard six bursts of small-arms and heavy machine-gun fire assessed as directed at its UAV (see above).
- On the same day, while conducting a mini-UAV flight near Berezove (government-controlled, 31km south-west of Donetsk), the SMM heard 18 bursts of small-arms fire assessed as directed at its UAV (see above).
- On the same day, while conducting a mini-UAV flight near Holubivske (non-government-controlled, 51km west of Luhansk), the SMM heard ten shots of small-arms fire assessed as directed at its UAV (see above).


