

Daily Report 87/2020

13 April 2020¹

Summary


- Compared with the previous reporting period, between the evenings of 10 and 11 April, the SMM recorded more ceasefire violations in both Donetsk and Luhansk regions.
- Between the evenings of 11 and 12 April, the Mission recorded fewer ceasefire violations in Donetsk region, compared with the previous 24 hours. It recorded no ceasefire violations in Luhansk region.
- The SMM saw damage caused by shelling to a functional school (currently closed due to the COVID-19 outbreak) and residential buildings in the Kuibyshevskyi district of non-government-controlled Donetsk city.
- Members of the armed formations continued to deny the SMM passage towards non-government-controlled areas at checkpoints near Olenivka and Oleksandrivka, Donetsk region, as well as towards non-government-controlled and government-controlled areas at a checkpoint south of the Stanytsia Luhanska bridge, Luhansk region.*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded ceasefire violations, including an explosion assessed as an impact of an undetermined weapon, in the disengagement area near Petrivske.
- The SMM monitored and facilitated adherence to localized ceasefires to enable maintenance of and repairs to civilian infrastructure on both sides of the contact line, as well as demining activities in non-government-controlled areas of Luhansk region.
- The Mission continued monitoring the situation of civilians amid the COVID-19 outbreak, including at entry-exit checkpoints and their corresponding checkpoints in both Donetsk and Luhansk regions.
- The SMM's freedom of movement continued to be restricted in both Donetsk and Luhansk regions.*



Number of recorded explosions⁴





In Donetsk region, between the evenings of 10 and 11 April, the SMM recorded more ceasefire violations, including, however, fewer explosions (about 20), compared with the <u>previous reporting period</u> (125 explosions). More than two-thirds of ceasefire violations were recorded in areas south-east of Hnutove (government-controlled, 90km south of Donetsk) and north of Shyrokyne (government-controlled, 100km south of Donetsk).

Between the evenings of 11 and 12 April, the Mission recorded fewer ceasefire violations, including fewer explosions (90), compared with the previous 24 hours. The majority of ceasefire violations were recorded in areas west of the railway station in Donetsk city (non-government-controlled, 6km north-west of Donetsk city centre), where about half of the explosions also occurred, and north of Shyrokyne.

In Luhansk region, between the evenings of 10 and 11 April, the SMM recorded more ceasefire violations, including more explosions (about 180), compared with the <u>previous reporting period</u> (90 explosions). The majority of ceasefire violations (all of which were explosions) were recorded at northerly directions of Kadiivka (formerly Stakhanov, non-government-controlled, 50km west of Luhansk).

Between the evenings of 11 and 12 April, the Mission recorded no ceasefire violations.

Damage by shelling to a school and residential buildings in Donetsk city

On 10 April, at 33 Vuhilna Street in the Kuibyshevskyi district of Donetsk city (non-government-controlled, 5km west of Donetsk city centre), about 30m south-west of a functioning school (currently closed due to the COVID-19 outbreak), the SMM saw a crater, assessed as fresh and caused by the impact of a mortar round.

The SMM saw fresh shrapnel damage to a door and to the south-west-facing side of a two-storey school building. The SMM also saw dislodged asbestos plates in the south-west-facing side of the building's roof.

About 185m south of the aforementioned crater, the SMM saw three other craters, all assessed as fresh and caused by probable impacts of mortar rounds.

About 25m south-west of the craters, the SMM saw damage to four inhabited residential houses on Zabiinykiv Street.

At 12 Zabiinykiv Street, the SMM saw shrapnel damage to the north-eastern-facing side of the house and a north-eastern facing wooden fence about 2m from it.

At 14 Zabiinykiv Street, the SMM saw a plastic sheet covering a north-eastern-facing window and glass shards on the ground under it.

At 16 Zabiinykiv Street, the SMM saw fresh shrapnel damage to the north-east-facing section of the tin roof and to the same-facing side of a single-storey house, in which it saw two shattered windows as well. It also saw fresh shrapnel damage to a metal fence about 2m from the house.

At 20 Zabiinykiv Street, the SMM saw fresh shrapnel damage to the north-eastern-facing section of the roof and to the same-facing side of a single-storey house, in which it saw a

shattered window as well. The SMM also saw shrapnel damage to the metal door of a garage located about 2m from the house.

Four people who introduced themselves as owners of the damaged houses (two women and two men, mixed ages) told the SMM that they had all been at their homes on the night between 1 and 2 April when they heard four explosions nearby.

Members of the armed formations continued to deny SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the Mission passage at checkpoints along official crossing routes in both Donetsk and Luhansk regions. These restrictions constitute an impediment to the implementation of the Mission's mandate.⁵

On 11 and 12 April, at a checkpoint near Olenivka (non-government-controlled, 23km south-west of Donetsk), members of the armed formations (some of them armed) denied the SMM passage towards non-government-controlled areas, providing no reason for the denial on the former date and citing quarantine restrictions due to COVID-19 on the latter (see SMM Spot Report 11/2020). *

On 12 April, at a checkpoint near Oleksandrivka (non-government-controlled, 20km south-west of Donetsk), members of the armed formations (some of them armed) denied the SMM passage towards non-government-controlled areas, citing quarantine restrictions due to COVID-19 (see SMM Spot Report 11/2020).*

On 11 and 12 April, at a checkpoint of the armed formations south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), members of the armed formations denied the SMM passage towards non-government-controlled and government-controlled areas, citing quarantine restrictions due to COVID-19 (see also SMM Spot Report 10/2020).*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁶

On 9 April, **inside the disengagement area near Stanytsia Luhanska** (government-controlled, 16km north-east of Luhansk), an SMM mini-unmanned aerial vehicle (UAV) spotted sections of burned vegetation starting about 25m west of the new span of the Stanytsia Luhanska bridge and extending for about 1.5km west-south-west and north-north-west (for previous observations in the area, see SMM Daily Report 10 April 2020). On 11 and 12 April, the SMM saw members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it.

On 11 and 12 April, inside the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), the SMM <u>again</u> saw five wooden logs lying across road T-1316, as well as two concrete blocks (with a sign atop one of them) on the edge of the road. On both days, members of the armed formations (wearing armbands with "JCCC" written on

them) near the southern edge of the disengagement area told the SMM that when entering non-government-controlled areas of Luhansk region, SMM members would be subject to a ten-day quarantine.*

On the morning of 11 April, while positioned about 1.5km north-west of Petrivske (non-government controlled, 41km south of Donetsk), the SMM saw dense smoke at an assessed range of 2-4km west-south-west, assessed as caused by a fire **inside the disengagement area near Petrivske.** While positioned about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk), the SMM saw a motorcade of seven cars drive in the direction of Starohnativka (government-controlled, 51km south of Donetsk) and return about 30 minutes later to leave the area.

On the morning of 12 April, while positioned outside the disengagement area, about 250m east of its north-eastern corner, the SMM saw five members of the armed formations carrying grass-cutting tools walking on a road towards Viktorivka (non-government-controlled, 42km south-west of Donetsk).

On the evening of 11 April, the SMM camera in Bohdanivka recorded ten projectiles in flight at an assessed range of 3-4km east-south-east, and on the same evening, the SMM camera in Petrivske recorded a projectile in flight at an assessed range of 1-2km south-south-west. All these ceasefire violations were assessed as inside the disengagement area. On the afternoon of 12 April, while positioned about 2km east of Bohdanivka the SMM heard and saw an explosion (assessed as an impact of an undetermined weapon) and saw black smoke rising at an assessed range of 2km south-east, both assessed as inside the disengagement area. While positioned about 500m north-west of Petrivske, the SMM heard five undetermined explosions at an assessed range of 3-5km south and assessed as outside the disengagement area but within 5km of its periphery.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

Indications of military and military-type presence inside the security zone⁷

The SMM observed armoured combat vehicles in the security zone in government-controlled areas of Donetsk and Luhansk regions (for further details, see the table below).

Presence of anti-tank mines near Nova Marivka

On 9 April, an SMM mini-UAV again spotted about 180 anti-tank mines about 3km southwest of Nova Marivka (non-government-controlled, 64km south of Donetsk), assessed as belonging to the armed formations (for previous observations, see SMM Daily Report 6 January 2020).

SMM facilitation of repairs to and operation and maintenance of critical civilian infrastructure, and of demining activities

On 11 and 12 April, the SMM facilitated and monitored adherence to localized ceasefires to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk), and on 11 April to enable repairs to water infrastructure in Pankivka (non-government-controlled, 16km north of Luhansk) and demining activities in Krasnyi Yar (non-government-controlled, 12km north-east of Luhansk).

On 11 and 12 April, the Mission continued to facilitate the operation of the Donetsk Filtration Station (DFS). During the day on 11 April, while positioned at a location near the DFS, the SMM heard about 60 shots and bursts of small-arms fire, all assessed as within a 5km radius of the DFS.

Measures at entry-exit checkpoints and corresponding checkpoints to counter COVID-19 outbreak

In Donetsk region, on 11 April, the SMM noted that the entry-exit checkpoints (EECP) near Marinka (government-controlled, 23km south-west of Donetsk) and near Novotroitske (government-controlled, 36km south-west of Donetsk) remained closed. On 11 and 12 April, it also noted that the checkpoint of the armed formations near Olenivka and that on 12 April the checkpoint of the armed formations near Oleksandrivka remained closed.*

In Luhansk region, on 11 and 12 April, the SMM saw that the EECP in Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example see SMM Daily Report 28 March 2020). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

On 11 and 12 April, at a checkpoint near Olenivka (non-government-controlled, 23km south-west of Donetsk), members of the armed formations (some of them armed) denied the SMM passage towards non-government-controlled areas, providing no reason for the denial on the former date and citing quarantine restrictions due to COVID-19 on the latter (see SMM Spot Report 11/2020).

- On 11 and 12 April, at a checkpoint of the armed formations south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), members of the armed formations denied the SMM passage towards non-government-controlled and governmentcontrolled areas, citing quarantine restrictions due to COVID-19 (see <u>SMM Spot</u> Report 11/2020).
- On 12 April, at a checkpoint near Oleksandrivka (non-government-controlled, 20km south-west of Donetsk), members of the armed formations again denied the SMM passage towards non-government-controlled areas, citing quarantine restrictions due to COVID-19 (see <u>SMM Spot Report 11/2020</u>).

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Conditional access:

- On 11 and 12 April, near the southern edge of disengagement area near Zolote (government-controlled, 60km west of Luhansk), members of the armed formations told the SMM that it would be subject to a ten-day quarantine when entering non-government-controlled areas.
- On 12 April, near a position of the armed formations close to Molodizhne (non-government-controlled, 63km west of Luhansk), an armed member of the armed formations told the SMM that it would be subject to a ten-day quarantine when entering non-government-controlled areas.

Other impediments:

- On 11 April, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Novohryhorivka (nongovernment-controlled, 61km north-east of Donetsk).⁸
- On 11 April, an SMM mid-range UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Slovianoserbsk (non-government-controlled, 28km north-west of Luhansk).
- On 12 April, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Shevchenko (non-government-controlled, 69km south of Donetsk).
- On 12 April, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Nova Marivka (non-government-controlled, 64km south of Donetsk).
- On 12 April, an SMM mini-UAV experienced GPS signal interference, assessed as caused by probable jamming, while flying over areas near Pervomaiske (non-government-controlled, 59km south of Donetsk).

When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions, technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.
