Summary


- Compared with the previous reporting period, between the evenings of 29 and 30 May, the Mission recorded fewer ceasefire violations in Donetsk region and more in Luhansk region.
- Between the evenings of 30 and 31 May, the Mission recorded fewer ceasefire violations in Donetsk region and more in Luhansk region, compared with the previous 24 hours.
- An SMM mini-unmanned aerial vehicle spotted recent impact craters caused by shelling in non-government-controlled Ozerianivka, Donetsk region.
- Members of the armed formations continued to deny the Mission passage at checkpoints along official crossing routes in Donetsk and Luhansk regions.*
- The Mission continued monitoring all three disengagement areas: it recorded ceasefire violations inside the disengagement area near Petrivske and observed persons near former positions of the Ukrainian Armed Forces inside the disengagement area near Zolote.
- The SMM saw weapons in violation of withdrawal lines on both sides of the contact line in Donetsk region.
- The Mission continued following up on measures taken amid the COVID-19 outbreak, including at entry-exit checkpoints and their corresponding checkpoints in Donetsk and Luhansk regions.
- Members of the armed formations continued to restrict the SMM's freedom of movement, including at a checkpoint in Horlivka and near two border crossing points in Luhansk region.*



Number of recorded explosions⁴





In Donetsk region, between the evenings of 29 and 30 May, the SMM recorded fewer ceasefire violations, including fewer explosions (about 160), compared with the <u>previous reporting period</u> (about 255 explosions). The majority of ceasefire violations were recorded at northerly directions of Shyrokyne (government-controlled, 100km south of Donetsk) and in areas east of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

Between the evenings of 30 and 31 May, the Mission recorded fewer ceasefire violations, including fewer explosions (15), compared with the previous 24 hours. The majority of ceasefire violations, including the majority of explosions, were recorded in areas north-west of Horlivka (non-government-controlled, 39km north-east of Donetsk) south-east of Chermalyk (government-controlled, 77km south of Donetsk) and at northerly directions of Shyrokyne.

In Luhansk region, between the evenings of 29 and 30 May, the SMM recorded more ceasefire violations, including more explosions (about 30), compared with the <u>previous reporting period</u> (about 20 explosions). The majority of ceasefire violations, including the majority of explosions, were recorded in areas north-east, south-west and west of the disengagement area near Zolote (government-controlled, 60km west of Luhansk) (see below).

Between the evenings of 30 and 31 May, the Mission recorded more ceasefire violations, including, however, fewer explosions (13), compared with the previous 24 hours. The majority of ceasefire violations were recorded at southerly directions of Kriakivka (government-controlled, 38km north-west of Luhansk).

Craters due to shelling near a non-operational industrial compound in Ozerianivka

On 20 May, an SMM mini-unmanned aerial vehicle (UAV) spotted eight craters assessed as recent impacts of rounds of undetermined weapons fired within a 400m radius (four assessed as fired from a north-westerly direction, one assessed as fired from a westerly direction and three of which the SMM could not assess the direction of fire) of an non-operational industrial compound on the south-western edge of Ozerianivka (non-government-controlled, 35km north-east of Donetsk), about 4.5km east of the forward positions of the armed formations.

Members of the armed formations continued to deny the SMM passage at checkpoints along the contact line in Donetsk and Luhansk regions

Members of the armed formations continued to deny the SMM passage at checkpoints in both Donetsk and Luhansk regions along official crossing routes. These restrictions constitute an impediment to the implementation of the Mission's mandate.⁵

In Donetsk region, on 30 May, at a checkpoint near Oleksandrivka (non-government-controlled, 20km south-west of Donetsk), an SMM patrol was <u>again</u> unable to proceed towards non-government-controlled areas due to the presence of metal bars and a pile of tyres, placed across the road for the first time.*

On 31 May, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed member of the armed formations again denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to COVID-19.*

In Luhansk region, at a checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), a member of the armed formations <u>again</u> denied the SMM passage toward government-controlled areas on 30 May and towards non-government-controlled areas on 31 May.*

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁶

On the night between 30 and 31 May, while in Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM heard eight shots of small-arms fire at an assessed range of 4-5km south-south-east, assessed as outside the disengagement area but within 5km of its periphery.

On 30 and 31 May, inside the disengagement area, the SMM saw members of the armed formations (wearing armbands with "JCCC" written on them) between the new span of the Stanytsia Luhanska bridge and their checkpoint south of it.

On 29 May, inside the **disengagement area near Zolote**, an SMM mini-UAV again spotted 25 anti-tank mines assessed as part of a larger mine field belonging to the armed formations, west of road T-1316 and about 650m north of the area's southern edge (for previous observations in the area, see SMM Daily Report 30 April 2020). On the evening of 29 May, an SMM long-range UAV spotted a person walking near a former position of the Ukrainian Armed Forces about 200m south of the area's northern edge and 500m west of its eastern edge. On the same evening, the UAV also spotted three persons near former positions of the Ukrainian Armed Forces—one near a position about 400m south and two near a position about 600m south of the area's northern edge.

On the evening of 29 May, while on the northern edge of Popasna (government-controlled, 69km west of Luhansk), the SMM heard about 30 undetermined explosions at an assessed range of 7-10km east-north-east and east-south-east, assessed as outside the disengagement area but within 5km of its periphery. Between the evening and night of 29 and 30 May, the SMM camera in Zolote recorded an illumination flare at an assessed range of 2-4km east-south-east (unable to be assessed as inside or outside the disengagement area) as well as 12 projectiles in flight at an assessed range of 3-5km east, assessed as outside the disengagement area but within 5km of its periphery.

On 30 and 31 May, the Mission saw members of the armed formations (wearing armbands with "JCCC" written on them) near the southern edge of the disengagement area. On both days, it saw two of them walking on road T-1316 inside the disengagement area up to about 350m north of its southern edge and subsequently exiting the disengagement area using the same road.

On the morning of 30 May, while positioned about 2km north of Petrivske (non-government-controlled, 41km south of Donetsk), the SMM heard 11 bursts and shots of small-arms fire, at an assessed range of 2-3km south-south-west, assessed as inside the **disengagement area**

near Petrivske. It also heard two undetermined explosions, at an assessed range of 5-7km south-west, assessed as outside the disengagement area but within 5km of its periphery.

On the night between 30 and 31 May, the SMM camera 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded five projectiles in flight at an assessed range of 1-3km east-south-east, assessed as inside the disengagement area. On the morning of 31 May, again while positioned about 2km north of Petrivske, the SMM heard an undetermined explosion at an assessed range of 4-5km south, assessed as outside the disengagement area but within 5km of its periphery.⁷

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum. It observed weapons in violation of withdrawal lines in government- and non-government-controlled areas of Donetsk region, including in a training area.

The Mission also observed weapons beyond withdrawal lines but outside designated storage sites in a government-controlled area of Donetsk region (for further details, see the tables below).

Indications of military and military-type presence inside the security zone⁸

The SMM observed armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions (for further details, see the table below).

On 31 May, while positioned about 1km north-west of the railway station in Yasynuvata (non-government-controlled, 16km north-east of Donetsk), the SMM saw five persons in military-style clothing exiting a recently dug trench assessed as belonging to the armed formations about 1km south-east of the Donetsk Filtration Station (DFS) (15km north of Donetsk), parallel to road M-04 (for more observations in the area, SMM Daily Report 2 May 2020).

Anti-tank mines in Shchastia, unexploded ordnance on eastern edge of Lebedynske and anti-tank mines signs in Mospyne

On 29 May, an SMM mini-UAV again spotted 12 anti-tank mines placed on a walkway next to a road about 170m west-north-west of the Siverskyi Donets river near Schchastia (government-controlled, 20km north of Luhansk), assessed as belonging to the Ukrainian Armed Forces.

On 30 May, the SMM <u>again</u> saw five mine hazard signs on the fence of an airfield near Mospyne (non-government-controlled, 24km south-east of Donetsk) as well as <u>again</u> saw a piece of unexploded ordnance (UXO) assessed as an artillery shell outside a compound on the eastern edge of Lebedynske (government-controlled, 99km south of Donetsk).

SMM facilitation of repairs to and operation of critical civilian infrastructure

The SMM facilitated and monitored adherence to localised ceasefires to enable vegetation clearance, inspection and maintenance of railway tracks near Vilkhove (government-controlled, 22km north-east of Luhansk) on 30 and 31 May.

The SMM continued to facilitate the operation of the DFS on 30 and on 31 May. While positioned at two locations near the station, the Mission heard shots of small-arms fire on 30 May, as well as heard two undetermined explosions on 31 May (all assessed as within a 5km radius of the station).

Border areas outside government control

On 30 May, the SMM noted that the border crossing point near Ulianivske (61km southeast of Donetsk) was closed and that there were no members of the armed formations onsite. During its presence, the SMM saw no cross-border traffic.

On the same day, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about 45 minutes, the Mission saw about 100 trucks (including with Ukrainian licence plates and "DPR" plates) queueing to exit Ukraine as well as, for the first time, wooden dividers between the lanes leading to and from the border crossing point.

The SMM also monitored border areas near Katerynivka (79km south-east of Donetsk), Manych (76km east of Donetsk) and Novoukrainske (77km east of Donetsk), where it observed a calm situation.

On 31 May, while at a border crossing point near Izvaryne (52km south-east of Luhansk), the SMM saw four pedestrians and two trucks with Belarusian licence plates entering Ukraine. After about five minutes, an armed member of the armed formations told the SMM to leave the area.*

The same day, shortly after reaching a border crossing point near Sievernyi (50km southeast of Luhansk), an armed member of the armed formations told the SMM to leave the area. During its presence, the SMM saw no cross-border traffic.*

Measures taken at entry-exit checkpoints and corresponding checkpoints amid COVID-19 outbreak

In Donetsk region, on 30 May, the SMM noted that the entry-exit checkpoint (EECP) near Marinka (government-controlled, 23km south-west of Donetsk) and the checkpoint of the armed formations near Oleksandrivka remained closed.*

On 31 May, the Mission saw that the EECP near Hnutove (government-controlled, 90km south of Donetsk) and the corresponding checkpoint of the armed formations west of Verkhnoshyrokivske remained closed.*

In Luhansk region, on 30 and 31 May, the SMM saw that the EECP in Stanytsia Luhanska and its corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge remained closed.*

On 30 May, while present in the area, the SMM saw 22 pedestrians (five men and 16 women of mixed ages and a child), crossing the EECP in Stanytsia Luhanska and the corresponding checkpoint of the armed formations towards non-government-controlled areas. According to a representative of the State Border Guard Service of Ukraine, five additional civilians (one man and four women of mixed ages) had crossed the EECP in the same direction before the arrival of the SMM. North of the new span of the Stanytsia Luhanska bridge, the Mission saw five members of an international humanitarian organization with two wheelchairs assisting people with limited mobility. South of the new span of the Stanytsia Luhanska bridge, the SMM also saw two members of the armed formations facilitating the crossing of these civilians. Near the checkpoint of the armed formation, the SMM saw two medical personnel, five members of an international humanitarian organization, an ambulance, additional medical vehicles and a bus.

The SMM also saw 40 pedestrians (mixed genders and ages), including eight children and two men with limited mobility, crossing the checkpoint of the armed formations and the corresponding EECP towards government-controlled areas.

The Mission continued monitoring in Kherson, Dnipro, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines and UXO and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see below). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- On 30 May, at a checkpoint near Oleksandrivka (non-government-controlled,20km south-west of Donetsk), an SMM patrol was <u>again</u> unable to proceed towards non-government-controlled areas due to the presence of metal bars and a pile of tyres (seen for the first time).
- On 31 May, at a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM passage towards non-government-controlled areas, referring to quarantine restrictions due to COVID-19.
- On 30 and 31 May, at a checkpoint south of the Stanytsia Luhanska bridge (15km north-east of Luhansk), a member of the armed formations <u>again</u> denied the SMM passage towards government-controlled areas and towards non-government-controlled areas, respectively.
- On 31 May, at a checkpoint west of Horlivka (non-government-controlled, 39km north-east of Donetsk), two members of the armed formations denied the SMM

- passage, referring to the presence of positions beyond the checkpoint, despite the patrol having specified that it needed to follow up on reports of a civilian casualty in the settlement.
- On 31 May, at a border crossing point near Izvaryne (non-government-controlled, 52km south-east of Luhansk), an armed member of the armed formations asked the SMM to leave the area.
- On 31 May, at a border crossing point Sievernyi (non-government-controlled, 50km south-east of Luhansk), an armed member of the armed formations asked the SMM to leave the area.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.


