
Daily Report 285/2021

4 December 2021¹

Summary

- In Donetsk region, the SMM recorded 286 ceasefire violations, including 131 explosions. In the previous reporting period, it recorded 809 ceasefire violations in the region.
- In Luhansk region, the Mission recorded 261 ceasefire violations, including 128 explosions. In the previous reporting period, it recorded 69 ceasefire violations in the region.
- Members of the armed formations denied the SMM passage towards government-controlled areas near Zolote and Molodizhne and delayed its passage near Stanytsia Luhanska, Luhansk region.*
- The Mission continued monitoring the disengagement areas near Stanytsia Luhanska, Zolote and Petrivske. It recorded ceasefire violations inside and near the disengagement areas near Stanytsia Luhanska and Petrivske and spotted people inside the disengagement area near Petrivske.
- The SMM facilitated the operation and maintenance of critical civilian infrastructure.
- The Mission continued following up on the situation of civilians, including at four entry-exit checkpoints and four corresponding checkpoints of the armed formations in Donetsk and Luhansk regions. The SMM heard and recorded ceasefire violations close to civilian infrastructure in and near Stanytsia Luhanska.
- The Mission saw two convoys crossing between government and non-government-controlled areas near Olenivka.
- The SMM observed three military-type trucks in border areas outside government control in Donetsk region.
- The SMM's freedom of movement continued to be restricted, including at two checkpoints of the armed formations and at a hospital in Donetsk region. Its unmanned aerial vehicles encountered instances of GPS signal interference, assessed as caused by probable jamming and jamming.*

Ceasefire violations²





In Donetsk region, the SMM recorded 286 ceasefire violations, including 131 explosions (one airburst, 18 outgoing and 112 undetermined). The majority of ceasefire violations occurred in areas north of Shyrokyne (government-controlled, 100km south of Donetsk); to the west of Yasynuvata (non-government-controlled, 16km north-east of Donetsk); to the south of Staromykhailivka (non-government-controlled, 15km west of Donetsk); and inside and south of the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk). In the previous reporting period, the Mission recorded 809 ceasefire violations in the region, some of which also occurred in areas north of Shyrokyne and close to the disengagement area near Petrivske.

In Luhansk region, the SMM recorded 261 ceasefire violations, including 128 explosions (six impacts, 11 undetermined and 111 outgoing and impacts). The majority of ceasefire violations occurred in areas to the south of the disengagement area near Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk) (see below). In the <u>previous reporting period</u>, the Mission recorded 69 ceasefire violations in the region, some of which also occurred near the disengagement area near Stanytsia Luhanska.

Following agreement reached at the meeting of the TCG on 22 July 2020 regarding Measures to strengthen the ceasefire, from 00:01 on 27 July 2020 until the end of the reporting period, the SMM has recorded at least 88,980 ceasefire violations in both Donetsk and Luhansk regions (including 24,490 explosions, 21,194 projectiles in flight, 403 muzzle flashes, 381 illumination flares and at least 42,512 bursts and shots).

Armed formations denied the SMM passage towards government-controlled areas near Zolote and Molodizhne and delayed its passage near Stanytsia Luhanska, Luhansk region

On 3 December, the armed formations in Luhansk region twice denied the SMM passage to government-controlled areas and once significantly delayed its passage.

The first denial occurred at 09:07 at the checkpoint of the armed formations near the southern edge of the disengagement area near Zolote (government-controlled, 60km west of Luhansk). The second occurred at 11:02 at a checkpoint of the armed formations on road T-0504 about 1.5km south-west of Molodizhne (non-government-controlled, 63km north-west of Luhansk). On the first occasion, members of the armed formations cited "the SMM's safety", and on the second - "orders from superiors".

The passage of another SMM patrol travelling through the checkpoint of the armed formations south of the Stanytsia Luhanska bridge (15km north-east of Luhansk) was delayed after armed formation members requested that Mission members comply with an inspection of luggage. The Mission refused the request and was allowed to pass only after about two hours.* (See SMM Spot Report 34/2021.)

Disengagement areas near Stanytsia Luhanska, Zolote and Petrivske⁵

Inside the **disengagement area near Stanytsia Luhanska**, the Mission saw six members of the armed formations (wearing armbands with "JCCC" written on them) south of the repaired span of the Stanytsia Luhanska bridge.

During the reporting period, the SMM cameras in Stanytsia Luhanska and at the Prince Ihor Monument south-east of the Stanytsia Luhanska bridge recorded five projectiles in flight and six muzzle flashes assessed as inside the disengagement area, and two muzzle flashes, nine explosions (three undetermined and six impacts) and 30 projectiles in flight assessed as outside the disengagement area but within 5km of its periphery.

While at the eastern edge of Stanytsia Luhanska, an SMM patrol heard 111 explosions (outgoing and impacts) and 90 bursts and shots of small-arms and heavy-machine-gun fire assessed as outside the disengagement area but within 5km of its periphery.

Near the checkpoint of the armed formations south of the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk), the SMM saw two members of the armed formations (wearing armbands with "JCCC" written on them). The Mission again saw the seven previously observed containers located south of the area's southern edge and inside the disengagement area. It saw that the previously reported road barriers across road T-1316, on the area's southern edge, continued to be closed.

During the day on 2 December, inside the **disengagement area near Petrivske** (non-government-controlled, 41km south of Donetsk), an SMM long-range unmanned-aerial vehicle (UAV) spotted one person inside a former position of the Ukrainian Armed Forces, about 2km east-south-east of its north-western corner, as well as one person inside a former position of the armed formations, about 30m west-south-west of the area's eastern edge and about 370m north-north-west of the area's south-eastern corner.

Outside the area, about 15m south of its southern edge, the same UAV also spotted two people walking north towards a former position of the armed formations near its south-eastern corner.

During the reporting period, the SMM camera about 2km east of Bohdanivka (government-controlled, 41km south-west of Donetsk) recorded ten projectiles in flight and nine undetermined explosions assessed as inside the disengagement area, as well as four undetermined explosions unable to be assessed as either inside or outside of the area. During the same period, an SMM patrol positioned on the western edge of Petrivske heard 16 bursts and shots of small-arms and heavy-machine-gun fire assessed as inside the disengagement area, as well as six undetermined explosions assessed as outside the disengagement area but within 5km of its periphery.

Withdrawal of weapons

The Mission continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

In violation of withdrawal lines, the SMM saw a mortar in a non-government-controlled area of Donetsk region.

Beyond withdrawal lines but outside designated storage sites, the Mission saw ten howitzers and 17 tanks, including at two railway stations in government-controlled areas of Donetsk and Luhansk regions. The Mission also observed 15 tanks and 28 pieces of artillery in a training area near Myrne in a non-government-controlled area of Luhansk region. (For further information, see the tables below.)

Indications of military and military-type presence in the security zone

The SMM observed three armoured combat vehicles in government-controlled areas of Donetsk and Luhansk regions. (For further information, see the table below.)

Presence of anti-tank mines near Sakhanka, Donetsk region.

On 2 December, about 2km south-south-west of the southern edge of Sakhanka (non-government-controlled, 97km south of Donetsk), an SMM mini-UAV spotted nine <u>previously</u> reported anti-tank mines laid across road M-14, assessed as belonging to the armed formations.

SMM facilitation of the operation and maintenance of critical civilian infrastructure

The SMM continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) (DFS). While positioned near Yasynuvata (non-government-controlled, 16km north-east of Donetsk), the Mission heard 31 undetermined explosions and three bursts of small-arms fire, assessed as within a 5km radius of the DFS. Nine of the explosions occurred during the transfer of DFS workers between the station and Yasynuvata.

The SMM also monitored adherence to localized ceasefires to facilitate electrical repair works near Tavrycheske (non-government-controlled, 76km south of Donetsk) and in Syhnalne (non-government-controlled, 23km south-west of Donetsk), as well as to power lines in Krasnohorivka (government-controlled, 21km west of Donetsk) and to water pipelines in Staromykhailivka (non-government-controlled, 15km west of Donetsk). While positioned at these last two locations, the SMM heard 17 explosions near Krasnohorivka, and 21 explosions and 24 bursts and shots of small-arms and heavy-machine-gun fire near Staromykhailivka.

Situation at entry-exit checkpoints and corresponding checkpoints

In Donetsk region, the Mission observed that the entry-exit checkpoint (EECP) near Novotroitske (government-controlled, 36km south-west of Donetsk) and the corresponding checkpoint of the armed formations near Olenivka (non-government-controlled, 23km south-west of Donetsk) were open, with civilian traffic passing through in both directions.

While at the corresponding checkpoint of the armed formations near Olenivka, the Mission observed a convoy consisting of ten trucks bearing the logo of an international humanitarian organisation, as well as one vehicle and one mini-bus bearing the logo of another international humanitarian organisation, travelling towards government-controlled areas. While at the same checkpoint, the SMM saw a convoy consisting of one mini-bus, two vehicles and four trucks, all of them bearing the logo of the same international humanitarian organisation, travelling towards non-government-controlled areas.

In Luhansk region, the SMM observed that the EECP near Stanytsia Luhanska and the corresponding checkpoint of the armed formations south of the Stanytsia Luhanska bridge were open, with people queueing to travel in both directions.

Between 15:30 and 16:20, while on the eastern edge of Stanytsia Luhanska, the SMM heard 111 undetermined explosions and 90 bursts and shots of small-arms and heavy-machine-gun fire assessed as inside the area. Between 15:45 and 16:05, the SMM cameras in Stanytsia Luhanska and at the Prince Ihor Monument south-east of the Stanytsia Luhanska bridge

recorded five projectiles in flight and six muzzle flashes assessed as inside the disengagement area. The aforementioned cameras also recorded two muzzle flashes, nine explosions and 30 projectiles in flight, which were assessed as outside the disengagement area but within 5km of its periphery. Some of these occurred close to a residential area of Stanytsia Luhanska, a railway line, and a road used by civilians and the SMM to cross the disengagement area. (See above and the table below.)

The Mission noted that the EECPs near Zolote and Shchastia (government-controlled, 20km north of Luhansk) were open, but that the corresponding checkpoints of the armed formations south of the disengagement area near Zolote and 3km south-east of the bridge in Shchastia were closed.

Along road T-1316, between the EECP near Zolote and the following intersection, on the western side of the road, the Mission observed four workers building a fence. (For previous observations in the area, see SMM Daily Report of 30 November 2021.)

Border areas outside government control

On 1 December, aerial imagery available to the SMM revealed the presence of a military-type truck at a compound near Samiilove (89km south of Donetsk), a probable military-type truck in a field about 2km south-east of Konkove (79km south of Donetsk), and a probable military-type truck at a compound in Markyne (94km south of Donetsk) in areas outside government control, all several kilometres west of the international border with the Russian Federation. (For previous observations in the areas, see SMM Daily Reports of 24 August 2021 and 12 November 2021.)

The SMM continued monitoring in Kherson, Lviv, Odessa, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kviv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Minsk agreements have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the Joint Centre for Control and Co-ordination (JCCC) should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the government (for example, see SMM Daily Report of 30 November 2021). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial:

- At a checkpoint near the Trudivski area of Donetsk city's Petrovskyi district (non-government-controlled, 15km south-west of Donetsk city centre), a member of the armed formations denied the Mission passage further south-west, citing "security reasons". The

SMM intended to follow up on a civilian casualty. While at the checkpoint, the Mission observed civilian traffic passing through.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Delay:

- At a checkpoint near Shevchenko (non-government-controlled, 69km south of Donetsk), two visibly armed members of the armed formations allowed the SMM passage south-west towards Tavrycheske (non-government-controlled, 76km south of Donetsk) only after 36 minutes of waiting, citing "security reasons". The Mission was travelling towards Tavrycheske to monitor a localized ceasefire to facilitate electrical repair works in the area. (See above.)

Other impediments:6

- Medical staff at a hospital in Horlivka (non-government-controlled, 39km north-east of Donetsk), refused to share information related to an alleged civilian casualty, citing a "need for permission" from those in control.
- SMM mini-UAVs experienced GPS signal interference, assessed as caused by probable jamming, during eight flights: on four occasions while flying over areas near non-government-controlled Luhansk city's Zhovtnevyi district, on two occasions while flying over Zolote-4/Rodina (government-controlled, 62km west of Luhansk), and once each while flying over areas near Zolote-2/Karbonit (government-controlled, 62km west of Luhansk) and Popasna (government-controlled, 69km west of Luhansk).



When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions technical limitations and/or other considerations. Ceasefire violations recorded by more than one patrol/camera and assessed to be the same are entered only once.
