DECISION No. 923 APPROVAL OF THE 2010 UNIFIED BUDGET

The Permanent Council,

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,
- 1. Approves the 2010 Unified Budget contained in Annex I;
- 2. Approves the Post Table contained in Annex II;
- II. Decides to allocate EUR 400,000 from the 2009 Mission in Kosovo approved budget to the 2010 Human Rights and Communities Programme in the Mission in Kosovo in addition to the funds approved in Annex I,
- III. Taking into account relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Underlining the oversight exercised by the participating States, and recalling Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee for Management and Finance (ACMF),

- 1. Reiterates its tasking to the ACMF, in co-ordination with the Secretary General, to improve further the programme and budget planning process within the OSCE;
- 2. Takes note of the latest version of the open-ended list of projects to be undertaken and funded within the 2010 Unified Budget, as contained in SEC.GAL/205/09, which may be supplemented by fund managers within their respective funds as appropriate in the course of 2010, and which should be updated and distributed to participating States twice in the course of the year;
- 3. Undertakes to intensify efforts, including throughout the Unified Budget cycle in 2010, to focus, streamline and prioritize the work of the Organization across the three dimensions in those areas where it has comparative advantage, and tasks the fund managers to ensure the coherence of their programme activities, in accordance with

the body of OSCE principles, commitments and decisions as well as their respective mandates;

- IV. Recalling Ministerial Council Decisions Nos. 18/06 and 19/06, taking into account Permanent Council Decision No. 705 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the Organization,
- 1. Reiterates the Secretary General's responsibility as Chief Administrative Officer of the Organization to implement duly the OSCE Financial and Staff Regulations and other decisions of the Permanent Council on financial and management issues, as well as to seek, obtain and execute relevant guidance from the Permanent Council in a timely fashion;
- 2. Tasks the ACMF to submit recommendations to the Permanent Council by the end of June 2010 on amendments to the OSCE's Financial Regulations;
- 3. Tasks the ACMF to submit recommendations to the Permanent Council by the end of April 2010 on possible improvements to the OSCE's Staff Regulations, to ensure that the Organization has in place the staffing mechanisms and necessary procedures, including with regard to transparent recruitment, to function efficiently and effectively, and, to this end, expressing its concern about the application of Article III of the Staff Regulations, requests the Secretary General to provide the participating States by the end of February 2010 with a report on the designation and recruitment of OSCE officials;
- 4. Welcoming the efforts of the ACMF to improve the efficiency and effectiveness of OSCE executive structures, in accordance with its terms of reference set out in Permanent Council Decision No. 552 of 27 June 2003, tasks the Secretary General to provide a report by the end of February 2010 on the state of implementation of relevant Permanent Council decisions pertaining to the management of the OSCE resources, and recommendations on outstanding issues to the ACMF;
- V. Referring to the replacement of the OSCE network operating system (PC.ACMF/54/09 of 10 November 2009),
- 1. Takes note of the Secretariat's intention to propose the establishment of a separate fund for the financing of the replacement of the OSCE's network operating system, which will be subject to a separate Permanent Council decision regarding approval and funding modalities, and undertakes to consider this proposal in due course within the ACMF.

DECISION No. 924 SCALES OF CONTRIBUTIONS FOR 2010

The Permanent Council,

Recalling Permanent Council Decision No. 850 of 15 May 2008 on the Scales of Contributions for 2008 and 2009,

- 1. Approves, as a provisional measure, the attached standard and field operations scales of contributions as contained in the annex, from 1 January 2010 to 31 December 2010;
- 2. Tasks the Advisory Committee on Management and Finance (ACMF) to begin discussions in January 2010 on the Scales of Contributions for 2011–2013, based on the below-mentioned criteria, by establishing an informal Working Group and requests the Chairperson of the ACMF to report to the Permanent Council on this matter by the end of June 2010;
- 3. Decides that the scales of contributions for 2011–2013 should be established in accordance with the following criteria:
- Gradual application of the principle of capacity to pay, based on the United Nations criteria for contributions;
- Political nature of the Organization;
- Revised level of the ceiling in the field operations scale for the contribution of any one participating State;
- A floor for the contribution of any one participating State;
- Revision of the scales every three years based on the above criteria and the current United Nations adjusted GNI figures.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"The United States of America wishes to make the following interpretative statement under paragraph IV.1(A)6 of the OSCE's Rules of Procedure.

In joining consensus on this scale of contributions decision, the United States has made no commitment to any further increases in the U.S. contributions levels. Permanent Council Decision No. 408, adopted in 2001, established a 14 per cent ceiling on the Field Operations (Vienna) scale. The logic behind that ceiling remains valid and we see no reason for changing it. Furthermore, in the thirty-fourth year since the Helsinki Accords were signed, we recall the significance of the concept of shared participating State responsibilities (for both the Helsinki and the Vienna scales), and we intend to participate in future discussions on that basis. Moreover, it remains our view that all criteria applied to future discussions on scales remain of equal weight.

We understand that these scales of contribution shall apply from January 1 through December 31, 2010 and that the reference in operative paragraph 1 to "as a provisional measure" shall have no effect on that period.

We request that this statement be duly registered and attached to the journal of the day.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Canada:

"Canada joins consensus on the decision on the scales of contributions for 2010 with the understanding that this decision represents only a guideline for the establishment of scales of contributions post-2010 and to this effect, does not:

- Impose limitations on the nature and scope of the discussions on scales of contributions past 2010 and of the recommendations that will eventually be made by the ACMF and the working group, and;
- Restrict in any way the possibility to discuss and adopt changes to the various criteria listed in operative paragraph 3.
