STATEMENT BY THE DELEGATION OF KAZAKHSTAN

Thank you, Mr. Chairperson,

I am instructed to draw your attention to and correct some reported versions of the remarks made by the Foreign Minister of Kazakhstan, Kassymzhomart Tokaev, at the *Mazhilis* — the lower chamber of Parliament — on 31 October, which might be interpreted by some in a way that distorts his words.

I would like to stress the fact that, neither in his introductory speech nor during a question-and-answer session with Kazakhstan members of parliament did the Minister mention a change in the timing of my country's bid to assume the office of the OSCE Chairmanship. Therefore, I confirm that Kazakhstan's bid for the Chairmanship in 2009 remains valid and intact.

I would once again like to assure my distinguished colleagues and partners that my delegation, as always, remains happy to provide them with all necessary information concerning topics of interest, and to invite them to contact us for clarifications if any are needed.

I kindly ask you, Mr. Chairperson, to include this statement in the journal of this meeting of the Permanent Council.
