By the Delegation of the Federal Republic of Yugoslavia:

"I would like to refer to the document PC.DD/67/00/Rev.3 and its part of the financing structure of the OSCE Mission in Kosovo.

According to our understanding it only means that some money is allocated to the Department for Elections without prejudge about the decision on elections themselves, which will be based on the future political decision.

I ask you, Madam Chairperson, to include this statement in the Journal of the day."

<u>Interpretative statement under paragraph 79 (Chapter 6) of</u> the Final Recommendations of the Helsinki Consultations

By the Delegation of Belarus:

"The delegation of Belarus welcomes the adoption of the decision regarding the approval of the OSCE budget for the year 2001. At the same time, in connection with the provisions of Section VIII of that decision, the delegation of Belarus has been authorized to make the following interpretative statement:

The Republic of Belarus regards the mechanism for preliminary consultations on the budgets of missions and field operations with the Government of the respective host State as a most important and essential element in the preparation and approval of the budgets of these missions and field operations and of the Organization as a whole.

Guided by this understanding, Belarus emphasizes the importance of conducting timely and detailed in-depth consultations on all mission and field operation projects, the implementation of which may be possible only after they have been approved by the Government of the host State."
