### DECISION No. 10/02 REVISED ANNOUNCING AND REMINDING MECHANISM

The Forum for Security Co-operation (FSC),

Recalling FSC.DEC/10/98 on the Announcing and Reminding Mechanism,

Reaffirming the commitment of the OSCE participating States to full and timely implementation of all measures agreed by them,

Determined to make further efforts to strengthen compliance by adhering to the annual deadlines established by various FSC commitments,

Recognizing the need to improve existing procedures in order to jointly promote the implementation and fulfilment of commitments by the participating States,

Decides to replace FSC.DEC/10/98 with the mechanism described below, which will apply to the implementation of agreed CSBMs as well as to other commitments established by FSC Decisions;

Authorizes the Chairperson of the FSC to take necessary action to implement the Announcing and Reminding Mechanism;

Tasks the Conflict Prevention Centre (CPC) to support the Chairperson of the FSC in the implementation of this mechanism.

#### **Announcing and Reminding Mechanism**

This mechanism will apply to the implementation of agreed CSBMs as well as to other commitments established by FSC Decisions.

#### Level A

- Two months before the relevant deadline (see Annex), the CPC will inform all participating States of their commitment(s);

- The CPC will offer available technical or administrative assistance, if requested, to any participating State.

#### Level B

- Not later than two weeks after the deadline, participating States will provide the FSC Chair with a written explanation for failing to meet the relevant deadline and will specify a date when the commitment will be met. At the same time this information will be copied to the CPC which will also provide it to all participating States;
- If within this two week period no explanation is forthcoming, the Chairperson of the FSC will send a reminder letter on behalf of the FSC to the participating State that has not fulfilled its commitment;
- The CPC will prepare the reminder letter;
- The Chairperson of the FSC will inform the Plenary of letters sent and of any replies subsequently received.

#### Level C

If no explanation is forthcoming, four weeks after the reminder letter has been sent, the Chairperson of the FSC will make direct contact with the participating State that has not fulfilled its commitment in order to determine:

- The reason(s) for failure to provide a written explanation and/or to respond to the Chair's reminder letter;
- The obstacles to compliance and/or implementation problems; and
- Possible needs for assistance and solutions.

The Chairperson of the FSC will inform the Plenary of the status of Level C contacts in a general manner.
