**WORKSHOP I: Propaganda of hatred in the media: self-regulation & journalism ethics**

*The current technological advances which provide millions of people around the globe access to the news and give them a platform to distribute news just as it occurs, also enables the distribution of fake news of distortions and incitement to violence against ethnic, religious and social groups. **WORKSHOP II: Digital broadcasting in Central Asia and Mongolia: challenges and potential solutions**

*The digital TV switchover has been a target for broadcasters and governments in Central Asia and Mongolia for over a decade, ever since the International Telecommunications Union set the date for the switchover as 2015. As elsewhere in the world, the DTV switchover in the region comes as a stress test for broadcasters*

*and regulators alike, both in technical terms and in terms of the social ramifications of the process. Unless certain rules and principles are taken into account by national governments and regulators, there may be a risk of negative effects of the switchover, e.g. less media pluralism, new barriers for cultural and linguistic diversity and for the free international flow of information. The level playing field in the licensing procedure is a necessary condition of ensuring media pluralism after the switchover is completed. The economic situation of the audience may become an important factor for the media outreach, thus necessitating social programmes on the part of the governments.*
