EFFORTS TO COMBAT ILLICIT AIR TRANSPORTATION OF SMALL ARMS AND LIGHT WEAPONS

Handling of the politico-military aspects

Matters to be considered

Measures that could be considered in the context of a best-practices guide:

- Separate monitoring of transport operations. The efficiency and regularity of customs control at points of entry and departure are of particular importance in this context;
- More systematic control, dependent on the capacity of different States, of cargoes originating in the territory of particular States or transiting their territory, if notice is received that they involve small arms and light weapons (SALW) or the ammunition belonging to those weapons;
- More systematic control, dependent on the capacity of different States, of cargoes originating in the territory of particular States or transiting their territory, if the flight plan of the aircraft includes countries subject to United Nations embargo or countries located in a regional zone engaged in conflict;
- Encouragement (given within the framework of a public-private partnership) of the air-transport sector to adopt and promote a code of conduct defining the measures to be taken to ensure that the documents accompanying arms cargoes contain complete and accurate information on the goods being transported and on the flight plans;
- Careful study of international agreements and national laws of participating States
 that are already in force in the air-transport sector, with particular reference to the
 norms laid down by the International Civil Aviation Organization and Annex 18 to
 the Chicago Convention on the transport of dangerous and explosive materials;
- Encouragement of States to give more effective application to the regulations in force in civil aviation.
