Protection of human rights defenders is vital to realize OSCE human rights commitments, says OSCE/ODIHR Director Link



The protection of human rights defenders is essential for OSCE participating States to realize their human dimension commitments in practice, OSCE/ODIHR Director Michael Georg Link said at the close of the 23rd OSCE Ministerial Council, in advance of international Human Rights Day on 10 December. "Human rights defenders are often the focus of threats, attacks and legal harassment

simply for trying to protect the rights of society's most vulnerable people, without discrimination," Director Link said. "I encourage OSCE participating States to seriously consider the Hamburg Declaration, which outlines many important actions to safeguard human rights defenders from restrictions contrary to OSCE commitments."

Effective and human-rights compliant policing in Roma and Sinti communities: OSCE/ODIHR training for law enforcement officers

This year, ODIHR developed and piloted an interactive two-day training on Effective and Human Rights Compliant Policing in Roma and Sinti Communities. It provides effective policing strategies in Roma communities that are fair and responsive to the needs of
