CHAIRPERSON'S NOTE ON THE 1091st PLENARY MEETING OF THE FORUM

The meeting was closed after multiple suspensions to consult on the draft agenda. The Russian Federation informed at the start of the meeting that it could not agree to the agenda as a protest to a presentation delivered by a guest speaker at the 1090th FSC on 9 October 2024.

The Chair then outlined its position that an agenda containing only standing items should not be subject to renewed weekly consensus. The full statement of the Chair has been distributed (FSC.DEL/338/24).

Following this, a high number of points of order from one participating State prevented the meeting to continue. This included a statement from the Russian Federation as a reply to the Chair's position (FSC.DEL/362/24).
