## STATEMENT BY THE DELEGATION OF THE NETHERLANDS

Madame,

1. I am instructed to convey to you our regrets and strong reservations as regards the modalities of the Rapporteur Mission to Belgrade.

2. We deplore the total absence of transparency. We are not aware of any consultations, in the Permanent Council, the Preparatory Committee or elsewhere, on what exactly the Mission was supposed to investigate or to explore, and along what parameters.

Nor were we informed about the timing and the composition of this Mission or the criteria of participation which were applied.

3. Furthermore, we wish to share with other interested members of the Permanent Council our concern about the course this Organization is taking. Increasingly we are witnessing a small group of non-elected Representatives benefiting from so many privileges of, apparently, a by now structural nature, that this is not only weakening the much cherished flexibility with which we wish to pursue our goals; it is also starting to affect this Organization in its core.

After all, Madame, the essence of consensus is the right to participate in the decision making process, and, even more, the right to know what is going on.

We feel more and more left out of that process.

4. My authorities wish it to be known that in our view the composition of the Rapporteur Mission to Belgrade can never be invoked as a precedent.

Furthermore, we wish this statement to be attached to the Journal of the Day.

May I request you, Madame, to undertake the necessary action to that effect.
