## STATEMENT BY THE EUROPEAN UNION

The European Union and its Member States welcome the adoption of the decision on the agenda of the Human Dimension Implementation Meeting and commend the Ukrainian OSCE Chairmanship for its efforts to reach consensus.

It is very important to adopt agendas in a timely manner to allow the ODIHR sufficient preparation time and to attract high-quality and high-level participation by governments and civil society.

As is the case for all OSCE institutions, we attach high importance to the work of the HCNM and welcome the appointment of the new High Commissioner, Ms. Astrid Thors. The fact that the HDIM 2013 begins with her address is an acknowledgement of the work of this important OSCE institution and it will be an opportunity for the new High Commissioner to present her views on how she intends to implement her tasks, similar to 2007 when Ambassador Knut Vollebaek was appointed.

Human rights and fundamental freedoms are essential to establishing the lasting order of peace, security, justice and co-operation. We believe that the HDIM should start with discussions on the implementation of our commitments relating to fundamental freedoms. It is not a matter of prioritizing some commitments over others, but of ensuring the efficiency of our discussion and the consistency of our recommendations throughout the HDIM with a view to fostering implementation of and further developing our OSCE commitments. We believe that this approach enhances our ability to thoroughly review all human dimension commitments.

Finally, we would like to note that agreement on a standing agenda would greatly improve the decision-making process and allow us to devote more time to substance rather than process. We look forward to engaging in further work on this matter.

Mr. Chairperson, we would kindly ask you to attach this statement to the journal of the day.

# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Thank you, Mr. Chairman.

I wish to express the appreciation of the United States for the Chair's patient efforts to facilitate a compromise enabling participating States to reach consensus on the agenda for the Human Dimension Implementation Meeting (HDIM) which will take place in Warsaw from 23 September to 4 October 2013.

As the Chairmanship has stated, this year is exceptional in that we celebrate the 20th anniversary of the High Commissioner for National Minorities (HCNM) as an institution. Moreover, we also have a new High Commissioner, Ms. Astrid Thors. And so, in a spirit of compromise, we agree as an exception to the standard order of discussion, to begin the first working session of the 2013 HDIM with a presentation by the newly appointed HCNM. We do so, however, despite deep reservations about the movement of discussions of fundamental freedoms in the OSCE region to later in the HDIM's first week.

As we have underscored on numerous occasions, the United States believes that the fundamental freedoms enshrined in international instruments are the basis of all our human dimension commitments and the foundation of all of our work in the human dimension. Exercise of the fundamental freedoms of expression, peaceful assembly and association, religion, and movement are closely intertwined. Where the exercise on line or off line of any fundamental freedom is impeded or denied, it is likely that the exercise of other fundamental freedoms also is obstructed. Without respect for fundamental freedoms, the human rights of members of minority groups may remain unprotected, the rule of law is compromised, independent media are stifled, accountability of government is hampered and democracy cannot thrive.

It is for this compelling reason that we have advocated starting each HDIM with the presentation by the OSCE Representative on Freedom of the Media on issues related to freedom of expression and followed closely by sessions devoted to the other fundamental freedoms. Precedent in doing so has been clearly established over the past five years, and this precedent should be respected in future HDIMs.

Our hope is that, with the contentious debate over the 2013 HDIM agenda behind us, we can work constructively on a standing agenda with fundamental freedoms at the forefront

that would guide future HDIMs and allow us to focus less attention on procedure and more on substance.

I request that this interpretative statement be attached to the decision and to the journal of the day.

## DECISION No. 1092 OSCE PROJECT CO-ORDINATOR IN BAKU

The Permanent Council,

Welcoming the fruitful co-operation established between the OSCE and the Republic of Azerbaijan,

Acknowledging the willingness of the Republic of Azerbaijan to further continue co-operation with the OSCE and make further progress in implementing commitments and principles,

Appreciating the work done by the OSCE Office in Baku to assist the Government of the Republic of Azerbaijan in implementing OSCE commitments and principles,

Aiming at adapting the established co-operation mechanisms between the Government of the Republic of Azerbaijan and the OSCE to reflect the current state of affairs,

Decides to transform the OSCE Office in Baku, upon the expiration of its existing mandate on 31 December 2013, into an OSCE Project Co-ordinator in Baku, which will perform the following tasks:

- To support co-operation between the Government of the Republic of Azerbaijan and the OSCE and its institutions aimed at implementing OSCE principles and commitments;
- To carry out planning and implementation of projects between relevant authorities of the Republic of Azerbaijan and the OSCE and its institutions. Such projects will cover all three dimensions of the OSCE's comprehensive security concept, taking into account the needs and priorities of the Government of the Republic of Azerbaijan;
- To that end to maintain contacts with governmental as well as non-governmental bodies, local authorities, universities, research institutions and NGOs of the Republic of Azerbaijan;

 To perform other tasks deemed appropriate by the Chairperson-in-Office or other OSCE institutions and agreed upon between the Government of the Republic Azerbaijan and the OSCE.

The OSCE Project Co-ordinator in Baku will be headed by a Co-ordinator who will be based in Baku together with his/her international and local staff.

The Co-ordinator will provide regular progress reports to the OSCE Permanent Council. The content of such reports will be shared beforehand with the Government of the Republic of Azerbaijan.

Modalities for the new form of co-operation based on this Permanent Council decision will be further elaborated in a separate Memorandum of Understanding to be signed by the Government of the Republic of Azerbaijan and the OSCE.

The mandate of the future OSCE Project Co-ordinator in Baku will enter into force on 1 January 2014 for an initial period of twelve months and with the possibility of subsequent extensions for one-year periods by mutual agreement between the OSCE and the Republic of Azerbaijan.

The budgetary needs of the OSCE Project Co-ordinator in Baku will be decided in the framework of the regular yearly decision-making process and covered out of the Unified Budget of the OSCE as well as by possible voluntary contributions.
