STATEMENT BY THE DELEGATION OF FRANCE (ALSO ON BEHALF OF AUSTRIA, BELGIUM, BULGARIA, CANADA, CROATIA, THE CZECH REPUBLIC, DENMARK, ESTONIA, FINLAND, GERMANY, IRELAND, LATVIA, LITHUANIA, MALTA, THE NETHERLANDS, SLOVENIA, SWEDEN AND THE UNITED KINGDOM)

Mr. Chairperson,

I am making this statement in a national capacity and also on behalf of Austria, Belgium, Bulgaria, Canada, Croatia, the Czech Republic, Denmark, Estonia, Finland, Germany, Ireland, Latvia, Lithuania, Malta, the Netherlands, Slovenia, Sweden and the United Kingdom.

Mr. Chairperson,

We appreciate the excellent work carried out by the OSCE Mission in Kosovo in order to support the authorities of the country in strengthening their institutions. We are pleased to welcome Ambassador Jan Braathu for his third report to the Permanent Council on the eve of the tenth anniversary of Kosovo's independence, an important date in the country's history, and we look forward to working with him in a constructive manner.

We welcome the fact that the Mission is gradually adapting its activities to Kosovo's needs. In that context, we once again express the hope that it will prove possible in the future to have contacts between participating States and technical representatives of the Kosovo administrations co-operating with the OSCE Mission in Kosovo. We regret that this was not possible yesterday at the informal meeting and should like to discuss the conceivable options as soon as possible with Ambassador Jan Braathu and all participating States prior to his next report to the Permanent Council.

STATEMENT BY THE DELEGATION OF SPAIN

Spain subscribes to the statement made by the European Union on this topic and would like as well to express its support for the important work carried out by the OSCE Mission in Kosovo together with other international institutions present on the territory of Kosovo. We should also like to thank Ambassador Jan Braathu for his statement and activity report and for the work that he is carrying out with his team.

Spain, like other participating States, does not recognize the territory of Kosovo as a State. In that regard, I should like to recall that any proposal or initiative regarding the OSCE Mission in Kosovo should be in keeping, as a frame of reference, with United Nations Security Council resolution 1244 (1999).

Progress in dialogue under the auspices of the EU between the authorities in Belgrade and Priština is an essential prerequisite in the pursuit by both of their respective paths towards Europe. In that regard, the territory of Kosovo has its own specific relational framework, namely the Stabilisation and Association Agreement.

DECISION No. 1287 USE OF CASH SURPLUS FOR STRENGTHENING THE INFRASTRUCTURE OF THE OSCE

The Permanent Council,

Acting in accordance with the relevant provisions of the Financial Regulations,

Taking into account the urgency to fund investments aimed at improving the efficiency of the Organization and strengthening the security of the OSCE's ICT systems,

Recalling the initial 2018 Unified Budget Proposal, identified with PC.ACMF/46/17 of 27 September 2017, with particular regard to the Fund of the Secretariat and the results of the budget discussions on this Fund,

Decides that:

506,800 euros from the 2016 cash surplus should be authorized to fund the infrastructure investments in the framework of the Fund of the Secretariat aimed at improving the efficiency of the OSCE, as per the annex.

ESSENTIAL INFRASTRUCTURAL INVESTMENTS

For the purpose of ensuring funding for ICT software and equipment, modernizing the technical recruitment solution and infrastructural needs in the area of web streaming and video conferencing, the essential infrastructural investments include funding for the following items:

ICT-related capital expenditures

The infrastructure assets represent part of the core organizational IT network infrastructure, serving not only the Secretariat, but all the other missions' network connectivity needs. It covers replacement of network switches, disaster recovery and security incident response services that are used in case of security breaches across the OSCE, for the necessary ICT security forensics, no matter the location of the breach. It also ensures coverage of needs for software maintenance and support fees required for the disaster recovery annual subscription and necessary infrastructure support and maintenance caused by the newly introduced Intranet portal, newly introduced security incident response and end-user protection services as well as replacement of the device management tool necessary for the Windows upgrade.

Modernization of the technical recruitment solution

Continued failure to modernize the recruitment technology has a significant impact on efficiency and the ability to provide timely recruitment and related reporting to all stakeholders. Modern tools are a key requirement for responsive service delivery and an aid to attracting the quality of talent the Organization needs to be successful. The lack of a modern system has become particularly apparent since the establishment of the Special Monitoring Mission to Ukraine.

Online registration tool and web streaming equipment

The allocated funding is to streamline and make the registration process more efficient and facilitate the process for both meeting participants and Conference Services. The in-house capability for web streaming and video conferencing would improve the technical preparations for relevant events. In addition, by enhancing the potential for remote participation in meetings, the investment could lead to savings in travel costs for meeting participants and broaden the scope of invitees and contributors to OSCE-related events.

Budget overview

The total budget of 506,800 euros is summarized in the table below and consists of one year operational and equipment costs.

Operational costs include 202,000 euros for software maintenance and support fees, 80,000 euros for registration tool and 98,800 euros for recruitment solution.

Equipment costs include 78,000 euros for mandatory capital replacement and 48,000 euros for equipment for an in-house mobile capability for web streaming and video conferencing.

DECISION No. 1288 APPROVAL OF THE 2018 UNIFIED BUDGET

The Permanent Council,

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,
- 1. Approves the 2018 Unified Budget contained in Annex I;
- 2. Approves the 2018 Unified Budget Post Table contained in Annex II;
- II. Taking into account relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Taking into account Permanent Council Decision No. 705 of 1 December 2005 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the OSCE,

Taking into account Permanent Council Decision No. 1216 of 21 July 2016 amending OSCE Staff Regulations and the recommendations contained therein,

Underlining the importance of the oversight of the OSCE's administrative and financial activities exercised by the participating States, and recalling Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee on Management and Finance (ACMF),

Taking into consideration financial constraints faced currently by the participating States and reiterating that any request for a supplementary budget during a financial year shall be met, wherever reasonable, by reallocating existing resources, and

Bearing in mind the previous discussions on unresolved, long-standing, horizontal issues, in particular with regard to the process to reform the secondment system and Board and Lodging Allowance (BLA),

Recalling Permanent Council Decision No. 1240 of 27 January 2017 carrying forward 848,994 euros to observe local elections in certain areas of the Donetsk and Luhansk regions of Ukraine as originally approved through a supplementary budget (PC.DEC/1177),

- 1. Undertakes to continue efforts, including throughout the Unified Budget cycle in 2018, to focus, streamline and prioritize the work of the OSCE across the three dimensions in those areas where it has comparative advantage;
- 2. Tasks the Secretariat and the ACMF to continue efforts to improve further the programme and budget planning process and the evaluation process within the OSCE in order to increase efficiency, transparency and accountability;
- 3. Extends for the 2018 Unified Budget the BLA methodology as described in PC.ACMF/20/17/Rev.1, pending the outcome of the ongoing process to reform the secondment system and tasks the ACMF chair to continue discussion on and look into solving long-standing horizontal issues, including the secondment system and BLA for all Unified Budget funded executive structures, Staff Standard Costs, Augmentation Fund, local staff income taxation and budget cycle, as a separate issue;
- 4. Tasks the fund managers to ensure full compliance of their programme activities with respective mandates and with the body of the OSCE principles, commitments and decisions;
- 5. Tasks all fund managers to distribute an open-ended list of Unified Budget projects to be undertaken and funded within the 2018 Unified Budget. The project list may be further supplemented by the fund managers within their respective funds, as appropriate, and an updated list should be issued to participating States twice a year;
- 6. Decides to establish a special fund for the purpose of carrying out observation of local elections in certain areas of the Donetsk and Luhansk regions of Ukraine that shall be set up for the duration required to carry out the activities. The fund shall be financed from the expired funds set aside for this purpose, carried forward through the Permanent Council Decision No. 1240 of 27 January 2017, and originally approved through a supplementary budget (PC.DEC/1177);
- 7. Calls upon participating States to reach an agreement in 2018 on future Scales of Contributions.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

The delegation of Bulgaria, in its capacity as EU Presidency, passed the floor to the representative of the European Union, who delivered the following statement:

"The Member States of the European Union welcome the adoption of the OSCE Unified Budget for 2018. They recognize the difficulty of this budgetary exercise in the current context and reiterate their support to the Italian Chairmanship in implementing it.

Unfortunately, as in previous years, this budget shows a lack of balance and operational credibility. It departs from the priorities of a very large majority of the OSCE participating States and ignores those of the EU Member States, although they account for 70 per cent of our Organization's budgetary contributions. The EU Member States remain committed to providing the Organization with adequate resources so that it can implement its comprehensive approach to security.

Moreover, this budget presents a number of recurrent difficulties. The limited number of credits allocated to the Office for Democratic Institutions and Human Rights (ODIHR) remains highly inadequate given the current issues and challenges and threatens its programmatic activities. It is a matter of extreme concern and jeopardizes the ODIHR's ability to fully accomplish its mandate. The Office in Warsaw sees its scope for action narrowed and threatened from year to year by the reduction in resources, in particular in the area of election observation, which merely exposes all of the participating States unnecessarily to demands for extrabudgetary funds made inevitable by this artificial reduction as a result of the will of a handful of States. We reiterate our support for the existing election observation methodology. It should not be called into question on account of budgetary constraints. We remain determined to rectify this situation and have spared no efforts in that regard.

The situation with respect to the budget for the Representative on Freedom of the Media is no less worrying. This institution should also receive more resources. We deplore the fact that, as every year, some countries continue to obstruct this in spite of the limited financial stakes and the commitments that they themselves have undertaken within the OSCE.

We reiterate our full support for the mandates of the three autonomous institutions and stress the importance and priority that we attach to their being provided with human and

financial resources sufficient for them to carry out their mandates properly. We recall that for more than five years their budgets have stagnated and even shrunk, despite the fact that the human dimension is at the core of the OSCE's mandate and indispensable for its accomplishment.

We regret the fact that a small number of States have blocked an upgrade of the post of the Senior Gender Adviser. The EU Member States will continue to promote gender equality in all of the OSCE's activities and strongly urge that practical measures be implemented to improve access to and the visibility of the Senior Gender Adviser.

We are willing to support the financing of investments in essential infrastructures through cash surpluses, insofar as such investments generate substantial savings in the future. We are not convinced, however, that these surpluses should or can be used systematically to cover reasonable expenses incurred through the OSCE's main activities within the Unified Budget.

It is regrettable that the field missions in Central Asia are still under-budgeted and the allocations correspond less and less to the security challenges encountered in that region.

We recall our strong support for better control of the costs of the Secretariat and note the inadequacy of efforts to control fixed personnel costs, demonstrating the need to find a lasting solution to this matter. We welcome the communication of key performance indicators and call for further efforts to improve evaluation mechanisms within the Secretariat.

We remain committed to supporting the positive impetus to reforms proposed by the Working Group on Horizontal Issues and currently being implemented by the Group of Experts established by the Italian Chairmanship.

We shall pay close attention to ensuring that the implementation of the new methodology for calculating board and lodging allowances (BLA) is reviewed with account taken of the ongoing reform of the secondment system. We continue to call for a more sustainable and rational BLA rate for the team of the Permanent Representative of the Chairperson-in-Office on the Conflict Dealt with by the Minsk Conference. The EU Member States will continue to place qualified personnel at the OSCE's disposal.

The discussion of the 2018 budget has also once again demonstrated the urgent need to find a solution for the Augmentations Fund with account taken of the financial arrangement adopted by the participating States regarding their level of contribution. We reiterate our support for the continued transfer of the posts concerned to the scale for the Secretariat.

We look forward to a rapid solution to the question of reimbursement from the Unified Budget of taxes levied by certain participating States on the income of local mission staff. The discussion and consultations that have taken place for many years have revealed directions that should now form the basis without delay for concrete and formal proposals by the Italian Chairmanship's committee of experts. We shall continue to follow this matter very carefully.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation:

"Having joined the consensus regarding the Permanent Council decision on the approval of the 2018 OSCE Unified Budget, the Russian Federation notes the following.

The OSCE budget is the key political document defining the programmatic activities of the OSCE institutions and field presences, which should be based exclusively on the decisions of our Organization's decision-making bodies and the agreed approaches to the work of all executive structures. It is therefore inadmissible to impose structural and staffing changes that are not based on positions approved by all participating States with respect to the OSCE's main tasks and areas of activity.

The Secretariat occupies the principal place among the executive structures, and therefore from the very beginning of the budget discussions the Russian Federation advocated adequate provision of resources to its units dealing primarily with conflict resolution, countering new threats and challenges, combating trafficking in human beings and developing economic co-operation. From the outset, we have supported the plans to upgrade the Secretariat's infrastructure, especially its computer networks with a view to increasing their level of protection against possible cyberattacks. We are therefore disappointed at the position of a number of participating States that demanded a substantial reduction in the budget requested by the Secretariat.

We note with regret the continuing imbalance in the financing of the OSCE's three baskets with a significant and unjustified bias in favour of the human dimension. We believe that the long overdue optimization of events in this area would help to restore the balance among the dimensions and make significant savings on resources, which could be used for conferences and seminars in the politico-military and economic and environmental spheres.

We have serious criticisms regarding the stubborn unwillingness of the Office for Democratic Institutions and Human Rights (ODIHR) to change its practice of double standards and do away with its unilateral approaches to programmatic activities. There is also need for improvement in the ODIHR's election observation methodology and practice, which should be based on agreed principles and rules for election monitoring. This will help to ensure full-scale and balanced monitoring of electoral processes in all OSCE participating States, without the need for additional funding. We trust that the ODIHR's senior officials

will heed the specific comments and proposals by the Russian Federation on all aspects of the Office's current and future work.

We also have substantive comments to make regarding the activities of the OSCE Representative on Freedom of the Media. The systematic disregard for significant problems regarding freedom of expression in the OSCE area is inadmissible, as are the imbalances in the work of that institution on such problems. I am referring, in particular, to the choice of different responses to similar situations depending on the State in question, which suggests bias. The Representative's inconsistency in assessing the persecution of journalists and media in OSCE countries, primarily in Ukraine, Latvia, Lithuania, Moldova, the United States of America, France and a number of other participating States, is disappointing. We therefore expect the Representative on Freedom of the Media to take a more objective approach to the fulfilment of his mandate, to which additional funding has now been allocated.

We note the need to increase transparency and proper accountability both of institutions and of field presences with regard to ongoing programmes and projects, which should be based on the instructions of the decision-making bodies and agreed upon in advance with the countries concerned. This applies to the use of both budgetary and extrabudgetary resources. We consider it necessary to continue the practice of regularly informing the participating States about the use by all executive structures of extrabudgetary resources, as was done in November 2017.

The Russian Federation maintains the importance of continuing the discussion on the secondment of staff to OSCE field presences. First and foremost, it is necessary to develop a mechanism for the balanced geographical distribution of posts in the OSCE executive structures – both contracted and seconded, including through their alignment with participating States' contributions. In that connection, we categorically oppose linking the reform of the secondment system with the classification of States on the basis of their financial capacity for supporting the staff of OSCE missions. All countries, including Russia, pay into the OSCE Unified Budget and thus collectively pay for their maintenance, regardless of their national identity.

As for the provision in the Permanent Council decision regarding the allocation of around 850,000 euros to observe local elections in Donbas, the Russian Federation assumes that this refers to monitoring by the ODIHR of elections in certain areas of the Donetsk and Luhansk regions of Ukraine in full accordance with Point 12 of the Package of Measures for the Implementation of the Minsk Agreements of 12 February 2015. We should like to recall that the document in question was endorsed by United Nations Security Council resolution 2202, which calls on all parties to fully implement the aforementioned Package of Measures.

We request that this statement be appended to the adopted decision on the approval of the budget and to the journal of the day."

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of France:

"France aligns itself with the interpretative statement made on behalf of the Member States of the European Union.

It would also like to make an interpretative statement in its own name under paragraph IV.1(A)6 of the Rules of Procedure of the OSCE regarding the following elements.

As in previous years, France cannot but regret that the adoption of the annual Unified Budget was the subject of tactical games motivated by political objectives not closely connected with the real discussion issues and contrary to the higher interests pursued within the OSCE. Moreover, it cannot but deplore the fact that its own legitimate interests and demands have been neglected as a result, in spite of the consistent financial and political support it has agreed to provide to our Organization.

In spite of the highly unsatisfactory nature of this budget, in particular because of the threats it continues to pose to the effectiveness of the autonomous institutions and several field missions, France has joined the consensus subject to the following interpretations:

- The omission from the Unified Budget of the costs of interpretation for the two
 preparatory meetings for the annual Economic and Environmental Forum because of
 the exceptional and unusual circumstance of their being held in two of the six official
 OSCE languages is a solution that should be regarded as definitive and permanent;
- The unusual and unjustified continuation of the Augmentations Fund, whose abolition has been demanded for too many years now, is no longer acceptable. France has decided to cease payment of the contributions unduly attributed to it in that regard and has notified the Secretariat of this decision. It urges the large majority of participating States, which are in the same situation, to do likewise;
- France reserves the right to do the same regarding its contribution to the inappropriate reimbursement to local OSCE mission staff of income tax that some participating States continue to levy, if concrete solutions are not proposed and implemented in 2018, as we indicated in our previous interpretative statement on the budget on 1 June 2017;

The new methodology for calculating the board and lodging allowance (BLA), whose inclusion in the 2017 budget France consistently opposed, has been provisionally renewed by the Permanent Council for 2018 and remains subject to review in 2018, particularly in relation to the reform of the policy regarding the employment of seconded staff, which is closely linked with the BLA. France cannot accept a misuse of the secondment system that would turn the BLA into a remuneration package compensating for the failure by certain participating States to pay the staff.

We naturally support the work on reform undertaken on the initiative of Italy within the Group of Experts on "structural" issues created by it for that purpose.

Finally, any increase in expenditure under the Organization's Unified Budget remains subject to the review of the current scales of contributions, whose simple renewal will not be considered by France.

If the OSCE participating States are on an equal footing in political terms, they are not equal when it comes to their financial contributions. We would recall once again that France is one of the main contributors to our Organization, accounting for over 10 per cent of its budget. The European Union and its Member States contribute 70 per cent of the OSCE budget, the North American participating States 20 per cent, and Switzerland and Norway 5 per cent, while 40 of the 57 participating States each contribute less than 1 per cent. This situation is untenable.

Mr. Chairperson, I request that this statement be appended to the decision adopted, and included in the journal of the day."

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"The United States wishes to make an interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure.

The United States joins others in commending the efforts of the Italian Chairmanship during difficult budget discussions this year. Without such leadership, today's decision on the 2018 Unified Budget would not have been made possible.

Mr. Chairperson, we have joined consensus on the 2018 Unified Budget because we believe in the OSCE and that it must have a budget to move forward with its critical programmes and activities. However, this budget is far from ideal and falls short in several critical areas.

We are disappointed that the budget does not sufficiently meet the resource needs of the OSCE's independent institutions: the Office for Democratic Institutions and Human Rights (ODIHR), the High Commissioner on National Minorities (HCNM), and the Representative on Freedom of the Media (RFoM). These institutions have been underfunded for many years, hampering implementation of the mandates that the participating States have given them: to assist participating States in meeting their OSCE commitments under the Helsinki Final Act and subsequent instruments. As responsible stewards of the OSCE's financial resources, we must ensure that these institutions receive adequate funding.

We regret that a small number of participating States has blocked the upgrade of the Senior Gender Adviser. The United States will continue to promote gender equality in all OSCE activities, and to encourage practical measures to improve access and visibility of this important post.

For yet another year, we are disappointed that the Border Management Staff College, one of Central Asia's only forums for regional border security and co-operation with neighbouring Afghanistan, was excluded from the Unified Budget.

The OSCE region has many growing security challenges. We call on all participating States to take a renewed look at the unique role of this Organization to meet security threats head on and to ensure that it has the resources necessary, when necessary, to carry out its vital mandates.

The United States requests that this statement be appended to the adopted decision and recorded in the journal of the day.

By the delegation of Austria:

"Austria is pleased with the adoption of the Unified Budget of the OSCE for 2018 achieved today and expresses its gratitude to the Chairmanship for its tireless efforts.

Alongside the interpretative statement by the Member States of the European Union which we fully share, we feel the necessity to make the following remarks in our national capacity as the host country and as recent Chairmanship.

We observe with growing concern the continued downward trend in the unified budgets of the OSCE. These reductions have been agreed over a prolonged sequence of years and for nearly all thematic and geographical areas. This has been happening not only in times of economic crisis but is also implemented in times of relative economic prosperity and in spite of rising security challenges – local, regional and transnational ones. This negative evolution is undermining more and more the capacity of our Organization to react to crises in the necessary and best way. As a consequence, this further damages our trust in its capabilities.

In this context, Austria calls on all delegations to provide the OSCE executive structures in the future with the resources they need for fulfilling their important mandates and goals. This includes ensuring continued access of the Organization to highly qualified staff on the international labour market by being able to offer attractive conditions, access to adequate technological means and sufficient financial resources. Any reform, also the ones of staffing, secondment and salary systems, needs to be carried out in this spirit.

We need to approach the negotiations for the 2019 Unified Budget in a renewed spirit of ownership, responsibility and support for our common and important endeavour."

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Holy See:

"Thank you, Mr. Chairperson.

Regarding the adopted decision on approval of the 2018 Unified Budget, the Holy See would like to make the following interpretative statement in accord with paragraph IV.1(A)6 of the OSCE Rules of Procedure.

The Holy See joins consensus on this decision with the understanding that its explicit task to all fund managers – 'to ensure full compliance of their programme activities with respective mandates and with the body of the OSCE principles, commitments and decisions' – will be the subject of careful consideration and dutiful implementation in good faith within the executive structures of the OSCE, including for the now enlarged 'Gender Issues' programme in the OSCE Secretariat.

The work undertaken by the 'Gender Issues' programme in the OSCE Secretariat is to be based on OSCE consensus-based commitments on promoting gender equality within the mandate of the executive structures of the OSCE, thus reflecting the participating States' decision to make equality between women and men an integral part of policies within the Organization.

The Holy See wishes to reiterate its understanding of equality between women and men within the work of the OSCE, recalling the continued validity of its interpretative statement made at the 535th plenary meeting of the OSCE Permanent Council and attached to Decision No. 638.

The Holy See fully supports the OSCE commitments aimed at a true and authentic equality between women and men and resolutely upholds the distinction with regard to sex, firmly believing that ''male' and 'female' differentiate two individuals of equal dignity, which does not however reflect a static equality, because the specificity of the female is different from the specificity of the male, and this difference in equality is enriching and indispensable for the harmony of life in society. Woman is the complement of man, as man is the complement of woman: man and woman complete each other mutually, not only from a physical and psychological point of view, but also ontologically. It is only because of the duality of 'male' and 'female' that the 'human' being becomes a full reality' (Compendium of the Social Doctrine of the Church, Nos. 147–148).

The Holy See is convinced that the best way to promote a full and true equality between women and men, and to increase women's role in society, is to counteract prejudice and negative stereotypes against women, to affirm the ontological equality in dignity and rights between men and women by using all juridical, cultural and social means, and not to separate 'gender' from sex or to affirm or advance a notion of a fluid gender personality.

Based on these fundamental principles, the position of the Holy See is guided by the following elements:

- 1. The term 'gender', as employed in the OSCE documents, is to be understood according to its ordinary and universally accepted usage, namely, two sexes, male and female, within the context of society.
- 2. In joining consensus on any decision or other action of the OSCE decision-making bodies that include the word 'gender', the Holy See does so with the exclusive understanding of the term 'gender' as two sexes, male and female, within the context of society.

While the Holy See certainly regrets that its appeal for serious discussion on the work incumbent on the 'Gender Issues' programme in the OSCE Secretariat was rejected by some participating States, it continues to consider such deliberations indispensable. My delegation stands ready to engage constructively in such discussions, assuring all the participating States that the Holy See's support for the implementation of consensually agreed OSCE commitments on advancing the promotion of equality between men and women remains unchanged.

Mr. Chairperson, I kindly request that this interpretative statement be attached to the decision and to the journal of the day.
