## **STATEMENT BY THE DELEGATION OF GERMANY**

Mr. Chairperson,  
Excellencies,  
Esteemed colleagues,

I am pleased to inform you today that Germany will continue to support the implementation of the Code of Conduct on Politico-Military Aspects of Security and in particular the regional seminar in Tirana from 21 to 24 April 2020.

The regional seminar will be a continuation of last year's successful series of events, which included the regional seminar in Cyprus and the symposium in Budapest.

In this context, we should like to recall the Commemorative Declaration of last year's Ministerial Council meeting, which underlined the special importance of the Code of Conduct for the OSCE area.
