# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Turkmenistan:

"In connection with the decision adopted on the agenda of the 2008 OSCE Human Dimension Implementation Meeting, we would like to make the following interpretative statement.

The delegation of Turkmenistan has joined the consensus on this decision in the firm belief that the Chairmanship, the ODIHR and the participating States will continue to work out a specific solutions to our specific concern.

The delegation of Turkmenistan understands that human right defenders have an important role in the work of this Organization and that dialogue between participating States and civil society is an important aspect in the implementation of OSCE commitments.

The delegation of Turkmenistan is seriously concerned about the fact that deficiencies in the registration process, lack of clear criteria and the inability to deal with clear cut problem cases has undermined trust in the human dimension implementation meetings.

Over the past five years, several individuals who committed terrorist act in Turkmenistan in November 2002 and were sentenced by the Supreme Court of Turkmenistan have been able to participate in various human dimension implementation meetings under the cover of various NGOs that they have set up afterwards to whitewash their past and escape punishment. And this happened irrespective of the fact that these individuals ideally fit the single OSCE criteria for exclusion of NGOs and individuals from the OSCE events contained in the Helsinki Document of 1992 that stipulates that persons or organizations that commit or condone terrorism or violence cannot be invited to OSCE events.

The delegation of Turkmenistan consistently provided the necessary information on the crimes committed by these individuals and protested against their participation in OSCE events. To our great disappointment, this issue has received its due attention only after certain steps were undertaken by our delegation.

The delegation of Turkmenistan shall be watching very closely the forthcoming Warsaw meeting and, if these individuals shall appear again, the delegation of Turkmenistan reserves the right to take all necessary steps to prevent criminals from participating in our events, including the use of the right to join consensus on our future HDIM events.

During the last period, several participating States have asked for more time to deal with this issue and work out an acceptable way out of this situation. The Government of Turkmenistan in a spirit of co-operation agrees to that and appeals to use this time to approach this issue seriously because next time we may not only remain with a lack of appreciation for and resolution of our specific concerns but in addition to that with a lack of consensus and, more importantly, with a lack of good-will and co-operation.

For Turkmenistan, co-operation with the OSCE is important, and we will do everything not allow criminals to derail this co-operation.

We heard the appeal of the Chairmanship and the participating States and we now hope that the Chairmanship and the participating States shall hear our appeal as well.

We ask that this statement be attached to the decision adopted and included as an annex to the journal of the day."
