### STATEMENT BY THE DELEGATION OF GERMANY

Mr. Chairperson,

The German delegation would like to inform the distinguished delegations of the Forum for Security Co-operation regarding a security policy conference held under the title "European Security and Arms Control".

The conference was organized by the George C. Marshall Center for Security Studies (GCMC), an American-German institution, in co-operation with the German Foreign Office. The conference took place last week, from 28 to 30 April 2010, in Berlin.

What is involved is an annual informal exchange of views that has been going on since 2003 regarding current security policy issues and that is aimed primarily at decision-makers from non-NATO and non-EU countries. This year, guests from 24 States took part.

From the German perspective this year's event, because of its comparatively high-ranking participants (three deputy ministers and two members of parliament) and the intensive discussions in the working groups, once again made clear the following: The subjects "Conventional Disarmament" and "European Security" are not only back on the agenda, but their discussion can, under certain circumstances, be energetically pursued this year.

It is to be hoped that the results of this exchange of views at the Berlin event will serve as an inspiration for consultations in the relevant international forums and bodies, especially here in the OSCE.
