Implementation status and future plans of the

OCEEA Anti-Trafficking Programme on Public-Private Co-operation in the Prevention of Trafficking in Human Beings (ATP)

(EF.GAL/16/04 2 June 2004)

1. Background

The Anti-Trafficking Programme on Public-Private Co-operation in the Prevention of Trafficking in Human Beings (ATP), in part building upon identified best practices, was developed following the guidance of the 11th OSCE Economic Forum on Trafficking in Human Beings, Drugs, Small Arms and Light Weapons: National and International Economic Impact (EF.GAL/13/03 Rev.1, 11 June 2003), and the OSCE Action Plan to Combat Trafficking in Human Beings, chapter IV. 7.2, 7.3, 8.5, and chapter V. 12.1 (PC.DEC/557, 24 July 2003), which was endorsed by the Maastricht Ministerial Council Decision No. 2. The OCEEA was called upon to formulate activities which would address the issue of trafficking in human beings by:

- mobilizing and strengthening private sector's efforts and creating public-private partnerships to combat trafficking in human beings.
- addressing the demand side of trafficking;
- developing programmes to tackle economic factors/root causes of trafficking and increasing opportunities for income generation in countries of origin.

The overall objectives of the ATP are to implement <u>preventive measures</u> and <u>integrate the private sector</u> into anti-trafficking activities in a manner that discourages demand and ameliorates the supply conditions that make women and children particularly vulnerable to exploitation. The meet these objectives the ATP has been divided onto three sub-programmes:

- I. Promoting self-regulation of the private sector
- II. Raising the awareness of trafficking in countries of destination, in particular in Western countries
- III. Creating economic empowerment opportunities for potential victims of trafficking.

The ATP was conceived as a 3 year umbrella programme (2004-2006). At present, Phase I of the ATP (2004-2005) consists of 8 project activities being implemented in 7 OSCE participating states.

2. Successes

- Establishment of new partnership structures among Ministry of Tourism, Ministry of the Interior/Police, national anti-trafficking units, civil society and business community.
- Creation of national multi-sectoral mechanisms to monitor local implementation of Code of Conducts.
- Strong internal OSCE cooperation among Office of the Special Representative, ATAU, ODHIR
- Pro-active engagement of the travel industry in SEE in self-regulation to address issues of sex tourism and sustainable tourism development.
- Good partner cooperation among NGOs, private sector and international community.
- Local ownership of project activities and continued replication without OSCE support.

3. Challenges

- Limited institutional experience in working with private sector
- Limited understanding by business community of its responsibility and role in anti-trafficking activities
- Need for greater political and resource commitment to economic empowerment activities as a means of prevention of (re)-trafficking
- Little/no donor commitment and OSCE consensus in addressing demand-side of trafficking in West/countries of destination
- Need for programme management support for OCEEA; difficulties in working with IRMA as it is not a project management system.

4. Status of Implementation

ATP Sub-Programme I: Promoting self-regulation of the private sector

OCEEA is encouraging private sector involvement as a preventive strategy in the fight against trafficking in human beings. In doing so, OCEEA has promoted the best practice "Code of Conduct for the Protection of Children from Sexual Exploitation in Travel and Tourism" developed by the tourism industry, together with the NGO ECPAT, as a model of public-private cooperation to be adapted to the local environment. OCEEA has targeted countries with developing tourism sectors in Southeast Europe that are also countries of origin and/or transit for trafficking in order to encourage a higher industry standard and help safeguard against the commercial sexual exploitation of children. Currently, the following two joint projects are being implemented using this model under this ATP Sub-programme I:

- o Bulgaria and Romania (first phase ending end of May 2005)
- o Albania and Montenegro (started in February 2005)

Public-Private Co-operation in Economic Empowerment for Potential Victims of Trafficking through Vocational Training: Launching IBLF's Youth Career Initiative in Romania			
Objective	To launch the Youth Career Initiative of IBLF in Bulgaria to provide, on a pilot scale, a six-month educational programme within the hotel industry for at-risk youth, including young people belonging to minority groups such as the Roma community. The educational programme will provide young people with vocational and life skills training to enhance their employment options and socio-economic choices in life, and thus mitigate the risk of them falling prey to human trafficking. Additionally, by promoting a best practice of Corporate Social Responsibility policy, the project sets an example and encourages other business sectors to get engaged in supporting economic empowerment activities.		
Achieved results	√ Six high school graduates, identified by UNICEF as coming from disadvantaged, backgrounds, were provided classroom and practical training within the Marriott Hotel in Sofia for a 26 week period. At the end of the programme, four of the participants were offered employment in the hotel.
