The national legislation of Finland has been amended to meet the requirements of the Ottawa treaty as well as other international arms control treaties that Finland is a state party to. In the latest issued training manual of the Finnish Defence Forces it is clearly described which weapons and/or mine systems are illegal and against international law. The implementation of different treaties has been assured by the Defence Command and irregular and regular inspections are conducted continuously.

Yes, Finland has capacity to assist in both training and advising. The decision on possible assistance is made by the Ministry for Foreign Affairs together with the Ministry of Defence.
