DECISION No. 839 APPROVAL OF THE 2008 UNIFIED BUDGET

The Permanent Council.

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003, cognizant of the provisions of Article II of this decision,
- 1. Approves the 2008 Unified Budget contained in Annex I, effective as of 1 January 2008;
- 2. Approves the Post Table contained in Annex II;
- II. Decides that the provisions of the 2008 Unified Budget and Post Table of the OSCE Mission to Georgia relating to the eight new Military Monitoring Officers (MMOs) shall take effect after close consultation with the head of mission and upon the adoption of a separate Permanent Council decision on their deployment,
- III. Taking into account Ministerial Council Decisions, *inter alia*, No. 17/06 on improvement of the consultative process, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE as well as Permanent Council Decision No. 780 on approval of the 2007 Unified Budget,
- 1. Tasks the Advisory Committee on Management and Finance (ACMF), in co-ordination with the Secretary General, to submit to the Permanent Council by the end of September 2008, proposals and recommendations on the further improvement of the programme and budget planning process within the OSCE;
- 2. Takes note of the open-ended list of Unified Budget projects to be undertaken and funded within the budget, as contained in SEC.GAL/232/07. The project list may be further supplemented by the fund managers within their respective funds, as appropriate, and an updated list should be issued to participating States twice a year;
- 3. Undertakes to intensify efforts, including in the context of the 2009 Programme Outline exercise, to focus and prioritize the work of the Organization across the three dimensions in those areas where it has a comparative advantage and tasks the fund

managers to ensure the coherence of programme activities, in accordance with the body of OSCE principles, commitments and decisions;

- IV. Recalling Ministerial Council Decision No. 19/06 and taking into account Permanent Council Decision No. 705 on the Common Regulatory Management System (CRMS),
- 1. Tasks the ACMF to discuss all outstanding issues relating to the amendment of the Financial Regulations of the OSCE and to submit recommendations thereon to the Permanent Council no later than 30 September 2008;
- V. Emphasizing the importance of proper human resources management for the effectiveness of the OSCE's activities, appreciating the Secretary General's close attention to this issue.
- 1. Tasks the ACMF to continue its deliberations on a compensation policy for locally recruited staff in the context of the 2009 Programme Outline and Unified Budget Proposal;
- VI. Taking note of the Secretary General's consultations with the respective host countries in 2007 on the exemption of locally recruited staff from income tax,
- 1. Undertakes to resolve the issue of income taxation of locally recruited staff.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Tajikistan:

"Mr. Chairman,

On behalf of the delegation of Tajikistan I am authorized to make the following interpretative statement to be attached to the journal of the day:

In supporting the Permanent Council Decision on approval of the 2008 Unified Budget the delegation of Tajikistan agrees with the increase of 19 per cent of the budget of the OSCE Centre in Dushanbe only for 2008, taking into account that this increase will be used for financing priority projects proposed by the Ministry of Foreign Affairs of the Republic of Tajikistan, in particular the arrangement of the Dushanbe International Conference on Water Related Disaster Reduction (27 and 28 June 2008), project on establishment of the Republican Information Press-Center and other projects."
