SESSION I: The digital transformation of the media industry and its effects on the practice and quality of journalism

The impact of the media technologies of digitalization on society is universal. It has many facets, from the switchover from analogue to digital broadcasting, to the Internet, and new-media technologies. This technological transformation empowers multi-directional communication, where the audience is invited to participate and interact, and enables changes in news production as well as in news consumption. However, it also forces the industry, primarily the legacy media, to reconsider business models for ensuring economic sustainability.

In addition, the social network platforms and news aggregators have been playing an important role in today's news distribution. They influence freedom and development of media in many ways, including by bringing access to a much larger audience than was previously feasible, introducing new approaches in distribution of revenues, reshaping control over the context in which content is promoted, promoting interaction with audiences, and affecting quality of information.

This session aims to address such issues as:

- *new and changing business models of media and their sustainability;*
- *diversification of revenues (grants, advertising, subscription, crowdfunding, sponsored content) and related implications on media consumption;*

- *opportunities by new technologies for journalism practice – citizen journalism and user-generated content;*
- *readership feedback and its effects on credibility and promotion of news;*
- *benefits and disadvantages of distributing news on social media platforms.*

SESSION II: Quality of information in the age of “fake news” and disinformation

Quality journalism can increase levels of political knowledge, participation, and engagement and can furthermore help reduce corruption and encourage elected officials to represent their constituents more effectively.

However, the current media environment in the OSCE region clearly shows that journalism has been greatly affected by such information disorders and challenges as violent political rhetoric, disinformation and propaganda, which may seriously undermine the public trust in media. It therefore becomes increasingly important, among other things, to enhance the capacity of media and journalists on investigative reporting, diversification, accountability, fact-checking and verification of information, to educate the public, and to promote media literacy.

- *disinformation and propaganda: challenges and opportunities for quality journalism;*
- *fact-checking initiatives;*
- *role of media in promoting media literacy.*

SESSION III: Regulation and self-regulation in the digital era

Adherence to recognized professional journalism standards and principles fosters editorial freedom, independence of media and pluralism, and contributes to the improvement of the quality of information. This process also goes hand-in-hand with

efforts to enhance media self-regulation and ethical journalism, both offline and online – important safeguards for media freedom and the social standing of journalism.

In recent years, some governments have moved to create or enhance state regulation to control information flows on the Internet and, sometimes, to censor online media content. There are efforts to regulate the work of social networks, compromise online anonymity, and define problematic information and speech in a broad manner without taking into account the digital nature of today's news media.

This session aims to address such issues as:

- *journalistic ethics and standards and its application on new media actors;*
- *self-regulation mechanisms and their recent practice;*
- *control over information, including on social media platforms: state interference, editorial responsibility and liability, and content moderation;*
- *application of traditional regulatory assumptions on new media and various media actors, and its effects on quality journalism.*
