DECISION No. 672 APPROVAL OF THE 2005 UNIFIED BUDGET

The Permanent Council,

- I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,
- 1. Approves the 2005 Unified Budget contained in Annex I;
- 2. Approves the Post Table contained in Annex II;
- II. Noting the improvements to the 2005 Unified Budget Proposal which have resulted in a greater degree of transparency and accountability in the Unified Budget process,
- 1. Encourages the Secretary General to further improve quality control of the narrative parts of the 2006 Programme Outline and 2006 Unified Budget Proposal to ensure that they fully correspond to the mandates of the relevant OSCE structures and are consistent with OSCE decisions:
- 2. Requests the Secretary General through the Department of Management and Finance, Conflict Prevention Centre, Internal Oversight and other relevant structures of the Secretariat to further improve the assistance and advice, including evaluation, provided to Fund Managers regarding formulation and implementation of project activities conducted within approved programmes and in accordance with their respective mandates, and in regard to the field operations in close consultations with the host countries;
- 3. Decides that Fund Managers shall provide an overview of project activities for which they are responsible in their regular reports to the Permanent Council, as a means of further improving the transparency of the OSCE's activities;
- 4. Takes note of the open-ended list of projects to be undertaken and funded within this budget as contained in SEC.GAL/100/05. The project list may be further supplemented in the course of 2005 by the Fund Managers within their respective Funds, as appropriate;

- 5. Further requests the Secretary General to submit by 30 September 2005 a report on the implementation of Financial Instruction 4/2004, including an evaluation of the extent to which OSCE activities are attaining desired outcomes in accordance with the Financial Regulations;
- III. Welcoming the efforts of the Advisory Committee on Management and Finance (ACMF) to improve the efficiency and effectiveness of OSCE structures, in accordance with its Terms of Reference set out in Permanent Council Decision No. 552 of 27 June 2003,
- 1. Tasks the ACMF to continue its deliberations on finding further efficiencies in the Organization's administrative structures and processes;
- IV. Recalling Permanent Council Decision No. 554 of 27 June 2003,
- 1. Tasks the ACMF to complete its review of the Financial Regulations, including provisions related to the management of extra-budgetary contributions, and to submit recommendations to the Permanent Council, *inter alia*, on ways to further improve the transparency of the OSCE's activities and accountability of Fund Managers no later than 15 December 2005;
- V. Taking positive note of the roll-out of the Integrated Resource Management (IRMA) system in 2005 and the ongoing reform of the Organization's management processes, as well as of the improved system of informing participating States through the Delegates' Website,
- 1. Tasks the ACMF to review the proposal for streamlining and re-aligning administrative support as a result of the OSCE Management Reform and IRMA (PC.ACMF/26/05 of 28 February 2005) with a view to provide its guidance to Fund Managers for incorporation in 2006 Unified Budget Proposal;
- 2. Notes the ongoing need for proper dissemination of information, improvement in the quality and ensuring correctness of OSCE publications in accordance with Permanent Council Decision No. 485 of 28 June 2002;
- VI. Reiterates the Secretary General's responsibility as Chief Administrative Officer of the Organization to duly implement the OSCE Financial and Staff Regulations and other decisions of the Permanent Council on financial and management issues, as well as to seek and obtain relevant guidance from the Permanent Council in a timely fashion;
- VII. Emphasizing the importance of proper human resource management for the effectiveness of the OSCE's activities, in particular through full application of the Staff Regulations,
- 1. Tasks the ACMF to finalize its deliberations on compensation policy for locally recruited staff;
- 2. Tasks the ACMF to continue the review of classification of professional and general service positions. Further tasks the ACMF to consider further measures to bring the classification of OSCE positions in line with the standards prescribed by the International Civil Service Commission;

- 3. Notes the existing practices of national income tax assessed on OSCE local staff salaries. Tasks the ACMF to review the recommendations contained in PC.ACMF/128/04 and to consider possible further measures to be undertaken. Further encourages the Secretary General to consult with the host countries on this issue;
- VIII. Referring to the OSCE's operational and other running costs,
- 1. Commends the Secretary General for his efforts to rationalize the use of the travel budgets, in particular through revision of Organization Directive on Travel, and requests him to effect further improvements in the planning and management of travel throughout the Organization;
- 2. Also commends the Secretary General for his efforts to rationalize the Information and Communication Technology (ICT) cost category and requests him to continue to take the necessary measures to further improve the Organization's policies and practices in this respect;
- 3. Notes the ongoing improvements in the OSCE's asset management practices, as a result of IRMA, and requests the Secretary General to continue to apply the principle of best value in asset purchases and maintenance. Further requests the Secretary General to refine OSCE write-off procedures and to submit relevant proposals to the ACMF not later than 15 September 2005;
- 4. Recalls Permanent Council Decision No. 590 of 24 December 2003 and notes the Secretary General's efforts to reduce rental costs for premises of OSCE field operations. Further encourages him to continue consultations with those host countries where the provisions of Memoranda of Understanding to provide the premises to the OSCE field operations free of charge, are not observed;
- 5. Notes the allocations under the budget line "Consultancy and Sub-contracting" and underlines that this budget line should not be used to circumvent the Post Table;
- 6. Recalls its request to the Secretary General in Permanent Council Decision No. 590 of 24 December 2003 to submit a proposal for improving management of the Organization's representation budgets to the Permanent Council;
- IX. Referring to the Secretariat's system of support to field operations ("augmentation"),
- 1. Tasks the ACMF to continue addressing this outstanding issue in the context of the Secretary General's ongoing review of the Secretariat's structures and to ensure that this system is treated in a manner consistent with the Organization's commitment to financial, administrative and budgetary transparency.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH 79 (CHAPTER 6) OF THE FINAL RECOMMENDATIONS OF THE HELSINKI CONSULTATIONS

By the Delegation of Luxembourg on behalf of the European Union:

"With regard to the decision just adopted by the Permanent Council, the delegation of Luxembourg, speaking also on behalf of the European Union, the acceding countries Bulgaria and Romania, the candidate countries Turkey and Croatia* and the EFTA country Norway, member of the European Economic Area, would like to make an interpretative statement under Paragraph 79 (Chapter 6) of the Final Recommendations of the Helsinki Consultations.

The delay in reaching agreement on the budget and the scales of contribution has been very damaging for the effectiveness, efficiency and credibility of the Organization and for the morale of its staff. This should not be allowed to happen again. This underlines the need to reach agreement on scales of contribution for 2005–2007 as soon as possible, and at the latest by 1 December 2005, as set out in the decision on the provisional financing arrangement for implementation of the 2005 Unified Budget.

The European Union would like to reiterate its full support for the action taken by the Secretary General earlier this year in issuing the first interim bill to participating States. The Secretary General has exercised his authority under the Financial Regulations, which contain all relevant provisions on budgeting and financing in the absence of an approved budget and scales of contribution, in order to ensure the continuing functioning of the Organization.

We underline that the decision adopted on the provisional financing arrangement is distinct from and in no way a substitute for the action taken by the Secretary General on interim billing. The decision does not therefore preclude the Secretary General having to take similar action in the future.

The EU is committed to the adoption of scales of contribution for 2005–2007, and to their retroactive application provided the decision is adopted preferably by 30 September 2005, but at the very latest by 1 December 2005.

The EU further remains committed to the principle of programme budgeting, as outlined in Permanent Council Decision No. 553 of 27 June 2003. We would like to recall that by adopting this Permanent Council decision, the OSCE has adhered to the principle of programme budgeting, recognizing the individual programme as the core element of the Unified Budget. The European Union views the indicative list of projects recently circulated under SEC.GAL/100/05 as a document of a purely informative nature.

Mr. Chairman, we request that this statement be attached to the Journal of the day."

"Canada very much regrets the late adoption of the 2005 Unified Budget and urges all delegations to respect the deadline for approval of the Unified Budget in future, as set out in the Financial Regulations. Failure to approve the 2005 Unified Budget in a timely fashion has impaired the OSCE's ability to carry out mandated activities and has damaged the Organization's credibility as a reliable international partner.

Canada also reaffirms its support for the principle of programme budgeting as outlined in Permanent Council Decision No. 553. In this context, we reiterate our position that the open-ended list of projects contained in SEC.GAL/100/05 should be used for informative purposes only.

Lastly, Canada does not recognize any connection between the institutional structure of the new Tolerance and Non-Discrimination programme in the ODIHR and the mandates of the three Special Representatives appointed by the Chairman-in-Office for 2005.

Taking note of this list of projects, we do, however, notice a number of shortcomings in it. Firstly, it does not, unfortunately, fully reflect the Organization's project activities in their entirety. Secondly, no financial data are given for the projects contained in the list.

We emphasize the need for further improvement in the planning of OSCE project activities as regards both the political priorities of the Organization and the preparation of its annual budget.
