INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation:

"We should like to make the following statement in connection with the OSCE Permanent Council decision on the supplementary budget for the OSCE Office for Democratic Institutions and Human Rights (ODIHR).

Having joined the consensus on the OSCE Permanent Council decision, the Russian Federation attaches prime importance to organizing an ODIHR observation of local elections in certain areas of the Donetsk and Luhansk regions, in full compliance with the 12 February 2015 Package of Measures for the Implementation of the Minsk Agreements.

We consider the holding of local elections in certain areas of the Donetsk and Luhansk regions, including compliance with OSCE standards for election monitoring by the ODIHR, an important step towards a stable and peaceful resolution in Ukraine. In that connection, the position of Ukraine is regrettable, as reflected in the decree of the Verkhovna Rada of Ukraine of 17 July 2015 that is not in line with the Package of Measures agreed in Minsk; according to that decree, the inhabitants of certain areas of the Donetsk and Luhansk regions are essentially denied the right to elect their own representatives at the local level.

We call on Ukraine to immediately address and agree on all issues related to the local elections in certain areas of the Donetsk and Luhansk regions with its representatives in the context of the relevant Contact Group mechanisms.

We take it that after agreement has been reached in the Contact Group, the ODIHR will promptly set about organizing the monitoring of these elections within the scope of the supplementary budget allocated today.

We request that this statement be attached to the decision adopted by the Permanent Council and to the journal of this meeting."

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Ukraine:

"Mr. Chairperson,

In connection with the decision on the 2015 supplementary budget for the Office for Democratic Institutions and Human Rights, the delegation of Ukraine would like to make the following interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

On 17 July 2015 the Verkhovna Rada of Ukraine adopted a Resolution N 645-VIII 'On calling regular elections of deputies to city councils and elections of village, small town and city heads in 2015', whereby regular local elections in Ukraine have been set for 25 October 2015 (except certain areas of Donetsk and Luhansk oblasts, as well as temporarily occupied Autonomous Republic of Crimea and the city of Sevastopol, Ukraine).

Recognizing the relevance of the OSCE observation for enhancing electoral and democratic processes, demonstrating openness and pursuant to paragraph 8 of the 1990 OSCE Copenhagen Document the Minister of Foreign Affairs of Ukraine extended an invitation, with his letter of 23 July 2015, to the OSCE Office for Democratic Institutions and Human Rights to observe the elections. Ukraine looks forward to ODIHR observation of these elections.

In line with the Minsk agreements the preparation and conduct of local elections in certain areas of Donetsk and Luhansk oblasts under the Ukrainian legislation and OSCE/ODIHR observation is discussed in the Trilateral Contact Group. The dates and modalities of these elections are to be decided by the Verkhovna Rada of Ukraine in accordance with the Ukrainian legislation.

The delegation of Ukraine believes that ODIHR should be provided with sufficient funding to be able to observe both of above-mentioned elections.

The delegation of Ukraine requests that this statement be attached to the decision and registered in the journal of the day.
