09.00 – 13.00 ROUND TABLE ON SELF-REGULATION OF TRADITIONAL AND ONLINE MEDIA

(parallel session)

Self-regulation mechanisms can protect media freedom and not endanger or destroy it. This session addresses the ways to protect media freedom and independence through online and offline self-regulation and the role of independent regulators.
