# STATEMENT BY THE DELEGATION OF THE RUSSIAN FEDERATION

The delegation of the Russian Federation regrets that the Forum for Security Co-operation (FSC) was unable to make its own contribution to the preparations for the second Annual Security Review Conference (ASRC). The reason for this was the position taken by the OSCE Chairmanship, which referred the discussion of all issues regarding the preparations for and holding of the ASRC to the exclusive competence of the "Group of Friends" of the OSCE Permanent Council. This approach contravenes both the decision of the Ministerial Council meeting in Porto regarding the FSC's contribution to preparations for the ASRC and also the mandate of the Forum itself. We regard these actions by the Bulgarian Chairmanship as illegal and inadmissible.

The Russian delegation recalls the need to observe OSCE decisions meticulously, including the decision of the Ministerial Council meeting in Bucharest on relations between the Permanent Council and the Forum, where the special status of the latter is confirmed.

We request that this statement be attached to the Journal of the day.
