There are clear regualations and guidelines which are aimed at excluding the indiscriminate use of mines, booby-traps and other devices.

The Republic of Armenia is interested in expanding its demining capabilities and modernizing its existing capacities.

6. Does your country have the capacity to assist others related to this Protocol? If so, please describe.

The Republic of Armenia is ready to assist other countries in demining activities within the limits of the capacities of the engineering divisions of its Armed Forces.

The capacity in the field of humanitarian demining, detection and disposal of improvised explosive devices are limited, but the sapper units of the Armed Forces are

ready to provide assistance to the extent possible. The Republic of Armenia does have a record of providing such assistance.

7. Has your country ratified or acceded to the 1997 Convention on the Prohibition of the Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on Their Destruction?

No. However, in the spirit of transparency and confidence building Armenia on the voluntary basis provides annual information on anti-personnel landmines to the UN and the OSCE.

The Government provides support to the families of the victims and the wounded. They receive financial assistance, stationary medical and rehabilitation treatment, including financing of prosthetic care.

The National Centre for Humanitarian Demining and Expertise implements projects on provision of legal assistance to mine victims, their inclusion in social programmes and their professional training. The Centre also seeks donor assistance to this end.

10. Does your country require assistance in mine clearance, stockpile destruction, mine awareness and/or victim assistance? If so, please describe.

"Center for Humanitarian Demining and Expertise" SNCO was established in Armenia with the US support in 2011. Armenia needs to expand its technical capacities in the field of demining. The following will be useful:

assistance for modernizing its demining devices, in particular demining robots, armoured equipment, modern mine-detectors, systems of electronic destruction of improvised explosive devices of remote control and protective uniform which will reduce the

risk of explosion while defusing mines, explosive remnants of war and improvised explosive devices.

Also, additional financial assistance to raise the awairness about the mine damages as well as to soppurt the victims thereof will be useful. It will also help to ensure protection and security for war-torn population.

11. Does your country have the capacity to assist others in mine action? If so, please describe.

Taking into account the humanitarian nature of the problem, Armenia stands ready and does assist other States in the demining operations within the limits of its current capacities.

Armenia has not yet ratified the Convention on Conventional Weapons.

In order to clear or otherwise minimize the risks and effects of ERW, emenating from the wars unleashed by Azerbaijan against Nagorno-Karabakh and Armenia, as well as the subsequent aggressions against and occupation of the sovereign territories of Armenia the sapper units of the RA Armed Forces are carrying out demining works in those areas.

At present, Armenia needs support to expand its technical capabilities in demining or ERW risk reduction.

4. Does your country have the capacity to assist others in clearing and minimizing the risks and effects of ERW? If so, please describe.

Taking into account the humanitarian nature of the problem, Armenia stands ready to provide assistance to other countries within the limits of its technical capacities. The Republic of Armenia does have a record of providing such assistance.
