# Project news: Roma and Antitrafficking

A new project fund to support NGOs tackling the trafficking of Roma was launched at a roundtable in Tirana on 18-20 September. The fund is a joint initiative of the ODIHR Anti-Trafficking Unit and the Contact Point for Roma and Sinti Issues.

The roundtable brought together both Roma and non-Roma NGOs and was aimed at exchanging expertise and knowledge about the problem, and building trust between community representatives and anti-trafficking organizations in both countries of origin and countries of destination.

# ODIHR to host annual human rights conference in Warsaw

The Human Dimension Implementation Meeting (HDIM) will be held on 2-13 October, Warsaw. Some 1000 participants from OSCE delegations, NGOs and international organizations are expected.



Keynote speakers will include **Thomas Hammarberg**, Commissioner for Human Rights of the Council of Europe, and OSCE Chairman-in-Office Belgian Foreign Minister **Karel de Gucht**.

# Needs assessment report ahead of the Almaty Freedom of assembly meetings in Warsaw and Almaty

The third roundtable in the ODIHR's project to consolidate its *Guidelines on Freedom of Assembly* was held in Almaty on 11 September. The meetings are a consultative exercise, bringing together a Panel of Experts established by the ODIHR for the purpose of commenting on the draft Guidelines, and representatives from relevant professions and institutions in the region.

All participants are invited to share good practices as well as challenges and concerns faced in regulating and handling public assemblies so as to draw the attention of the Expert Panel to these practical issues and to take them into account when re-drafting the Guidelines.

The fourth and final roundtable will be held on 16 October in Warsaw, and will be attended by representatives from Belgium, Czech Republic, Italy, Latvia, Netherlands, Poland, Spain, Sweden, United Kingdom, United States and Canada.

At the end of the consulation process, the Panel will revise the Guidelines, with a final version to be ready by the end of 2006.

## Tolerance education meeting

The second OSCE Tolerance Implementation Meeting, on *Education to promote Mutual Respect and Understanding and to Teach about the Holocaust,* will be held in Dubrovnik on 23-24 October. The event, which brings together education experts, is jointly organized by the OSCE Chairmanship and the Croatian authorities.
