STATEMENT BY THE DELEGATION OF IRELAND

Mr. Chairperson,

I take the floor to record that Ireland has made an extrabudgetary contribution of EUR 100,000 to the Special Monitoring Mission to Ukraine.

With our partners in the European Union, we have supported the efforts of the Chair-in-Office and the OSCE in the present crisis. As we said in our EU statement this morning, with which of course Ireland is associated, in these difficult days we support the work of the OSCE-facilitated Trilateral Contact Group, which has another important meeting tomorrow. We hope that by creating the conditions for a sustainable ceasefire, the Contact Group can open a space for a creative political process, as reflected in President Poroshenko's peace plan and in the principles implicit in a national dialogue embracing all Ukraine.

The suffering imposed by any continuation of the conflict – as documented by international agencies – imposes responsibilities on all parties.

Ireland is committed to the long-term strategy of strengthening – without sacrifice of principle – the role of the OSCE as a platform from which to develop a co-operative approach to security based on shared values and actions across all three dimensions. The "micro" of individual situations can benefit from the "macro" of this wider political objective. Let us not forget that many of our partner countries in Asia and the Mediterranean are looking to our Europe of the 57 to become more than the sum of its parts and to set an example of co-operative security and settling disputes by peaceful means. We support the Swiss Chairmanship in its efforts to promote longer-term thinking within the OSCE.

I request that this statement be attached to the journal of the day.
