STATEMENT BY THE DELEGATION OF SPAIN

Mr. Chairperson,

I have the honour to inform the Permanent Council that the High-Level Conference on Victims of Terrorism, organized within the framework of the Global Counterterrorism Forum (GCTF), was held in Madrid on 9 and 10 July.

As we know, the Global Counterterrorism Forum is an open forum for dialogue and discussion to promote international co-operation in the fight against terrorism within the general framework of the United Nations Global Counter-Terrorism Strategy, for which the OSCE expressed its support in the Ministerial Declaration of November 2007.

It should be recalled that this Ministerial Declaration states in paragraph 24 that "The OSCE will continue addressing the issue of solidarity with the victims of terrorism, drawing, *inter alia*, on Permanent Council Decision No. 618 on solidarity with the victims of terrorism and taking note of the High-Level Meeting on Victims of Terrorism held in Vienna in September 2007".

Mr. Chairperson,

In choosing Madrid as the city to host the High-Level Conference on Victims of Terrorism, the Global Counterterrorism Forum recognized Spain's experience and leadership in dealing with the victims of terrorism and its decisive involvement in combating this threat to the security of human beings and States.

For two days, experts from 30 countries affected by the scourge of terrorism and from international organizations shared experiences and good practices in terms of the work undertaken by national governments to support and assist victims of terrorism.

This conference enabled victims of terrorism and representatives of victims' associations to make the experts aware of the various ways in which they help to combat extremist rhetoric and prevent terrorism in general.

The topics covered in the presentations were: (1) the models of support and assistance to victims of both international and domestic terrorism, (2) the role of victims and victims' associations in the prevention of terrorism and violent extremism, (3) the establishment of federations of victims' associations and interaction between the State and these associations, (4) the media and victims of terrorism, and (5) the follow-up activities agreed within the Global Counterterrorism Forum.

The Madrid Declaration on Victims of Terrorism was agreed upon in the last session and sets out the main results of the Conference and an Action Plan. The complete text was distributed yesterday, 11 July, under reference number SEC.DEL/213/12 in order to provide delegations with more information.

Mr. Chairperson, I should be grateful if the text of this statement could be attached to the journal of today's meeting.

Reiterating the importance of full transparency and accountability in the functioning of the OSCE, and welcoming the progress made by the Secretariat with regard to the adoption of International Public Sector Accounting Standards,

Taking note of the Financial Report and Financial Statements for the year ended 31 December 2011 and the Report of the External Auditor (PC.ACMF/37/12 of 21 June 2012),

- 1. Accepts the Financial Report and Financial Statements for the year ended 31 December 2011;
- 2. Requests the Secretary General to establish and submit to the Advisory Committee on Management and Finance not later than 31 October 2012 a work plan for follow-up to the recommendations of the External Auditor as reflected in its Report for 2011. Further requests the Secretary General to inform the Permanent Council through the Advisory Committee on Management and Finance about the implementation of this plan on a regular basis, taking into account guidance from the Advisory Committee on Management and Finance.
