INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of Kyrgyzstan (also on behalf of Azerbaijan, Kazakhstan and Turkey):

"In accordance with the OSCE Rules of Procedure, Paragraph IV.1(A)6 and with regard to the decision just adopted by the Permanent Council on the timetable and organizational modalities of the 19th Meeting of the OSCE Ministerial Council, Kyrgyzstan in its capacity of the Chairperson of the Council of Heads of States of the Cooperation Council of Turkic Speaking States (CCTS) and on behalf of Azerbaijan, Kazakhstan and Turkey makes the following interpretative statement:

While joining the consensus on this decision in a spirit of compromise, we deem it necessary to raise our concern to the fact that the list of international organizations to be invited to the 19th Ministerial Council once again falls short of meeting the comprehensiveness and inclusiveness that our Organization is built upon.

The decision just adopted is the outcome of a course of events void of dialogue and which led to the exclusion of two international organizations from the list, exclusively comprised of four OSCE participating States is a matter of deep regret.

In a situation where similar organizations based on linguistic bonds are on the list and have been participating in OSCE events for years, refraining from extending invitations to the Cooperation Council of Turkic Speaking States and the Parliamentary Assembly of Turkic Speaking Countries for the Ministerial Council meeting in Dublin contradicts the spirit and letter of basic documents of the OSCE.

In this context, we would like to inform participating States that in the future, we will not accept the list adopted today as a basis for further decisions related to the modalities of OSCE events, including the 20th Meeting of the OSCE Ministerial Council.

With this understanding, we also call on the incoming Ukrainian Chairmanship to chart our discussions on modalities of OSCE events in 2013 on a basis different from this year, when we were deprived of the opportunity to have even discussion on the issue. The approach should be inclusive, avoiding discrimination between international organizations that have a similar character.

I request that this statement be attached to the journal of the day, and to the decision in question."
