### STATEMENT BY THE EUROPEAN UNION

Mr. Chairperson, the European Union welcomes the adoption of the decision on the agenda for the 2007 Human Dimension Implementation Meeting.

However, the European Union deeply regrets that its proposal to include a working session exclusively dedicated to freedom of association and assembly was rejected by some participating States, even though these freedoms have been recognized in OSCE human dimension commitments and major international human rights instruments as cornerstones of a free and democratic society.

We call on participating States to respect the principle that the Human Dimension Implementation Meeting should provide the opportunity to review the full range of OSCE commitments in the human dimension with adequate time.

Recalling with concern that in its 2006 Common Responsibility Report the ODIHR noted that freedom of association and assembly was at threat in some OSCE participating States, the European Union emphasizes that promoting the full enjoyment of these fundamental rights should remain at the forefront of the OSCE's priorities and we reserve the right to raise the subject at any appropriate moment during the Human Dimension Implementation Meeting.

Mr. Chairperson, I request that this statement be attached to the journal of the day.

The candidate countries Turkey, Croatia and the former Yugoslav Republic of Macedonia<sup>\*</sup>, the countries of the Stabilisation and Association Process and potential candidates Albania, Bosnia and Herzegovina, Montenegro, and Serbia, EFTA countries Iceland, Liechtenstein and Norway, members of the European Economic Area, as well as Ukraine, the Republic of Moldova and Georgia align themselves with this statement.

Croatia and the former Yugoslav Republic of Macedonia continue to be part of the Stabilisation and Association Process.
