DECISION No. 351 SUPPLEMENTARY BUDGET FOR OSCE TASKS IN BOSNIA AND HERZEGOVINA RELATING TO THE SUPERVISION OF THE GENERAL ELECTIONS IN THE YEAR 2000

The Permanent Council,

Acting in accordance with the relevant provisions of the Financial Regulations (DOC.PC/1/96) as approved by the Permanent Council on 27 June 1996, and

Recalling its Decision No. 350 of 18 May 2000 concerning the supervision and dates of the general elections in Bosnia and Herzegovina,

- Adopts a supplementary budget for OSCE tasks in Bosnia and Herzegovina to finance the OSCE activities relating to the supervision of the general elections in Bosnia and Herzegovina in the total amount of EUR 6,975,200; the budget will be implemented on the basis of Alternative 1 of the Secretary General's proposal of 12 May 2000 (PC.IFC/33/00) as subsequently amended and shown in the Annex;
- Calls upon participating States, Partners for Co-operation, Mediterranean Partners for Co-operation and other States, as well as international organizations and other institutions, to consider making voluntary contributions for the purpose of partial financing of the budget relating to supervision of the general elections in Bosnia and Herzegovina in the year 2000;
- Appeals to Bosnia and Herzegovina to allocate funds for the general elections in the year 2000.

While accepting OSCE supervision of the general elections in the year 2000, the Permanent Council regrets the fact that, due to the non-adoption of the permanent election law, the general elections cannot be organized under the full responsibility of the competent authorities of Bosnia and Herzegovina.

The Permanent Council does not expect the OSCE to supervise future general elections in Bosnia and Herzegovina and urges the Parliamentary Assembly of Bosnia and Herzegovina to adopt the permanent election law without further delay and to allocate appropriate resources for future elections.
