DECISION No. 981 APPROVAL OF THE 2011 UNIFIED BUDGET

The Permanent Council,

I. Acting in accordance with the relevant provisions of the Financial Regulations and Permanent Council Decision No. 553 of 27 June 2003,

1. Approves the 2011 Unified Budget contained in Annex I;

2. Approves the Post Table contained in Annex II;

II. Recalling relevant Ministerial Council Decisions, *inter alia*, No. 18/06 on further strengthening the effectiveness of OSCE executive structures and No. 19/06 on strengthening the effectiveness of the OSCE,

Taking into account Permanent Council Decision No. 705 of 1 December 2005 on the Common Regulatory Management System (CRMS), and striving to contribute to strengthening the efficiency, effectiveness and transparency of the Organization,

Noting the Permanent Council Decision No. 945 of 13 July 2010 on amending OSCE Staff Regulations and expressing its appreciation for the work done in 2010 by the Informal Working Group on Financial Regulations,

Underlining the importance of the oversight of the OSCE's administrative and financial activities exercised by the participating States, and recalling the Permanent Council Decision No. 552 of 27 June 2003, setting out the responsibilities of the Advisory Committee on Management and Finance (ACMF), and

Taking into consideration financial constraints faced currently by the participating States,

- 1. Tasks the ACMF, in co-ordination with the Secretary General, to continue efforts to improve further the programme and budget planning process within the OSCE, *inter alia*, taking into account the relevant proposals made in the framework of the Corfu Process and the preparations for the Astana Summit meeting;
- 2. Tasks the ACMF to intensify its work on reaching an agreement on the OSCE Financial Regulations and possible amendments to the OSCE Staff Regulations and

submit its recommendations on these subjects to the Permanent Council by the end of June 2011;

- 3. Takes note of the latest version of the open-ended list of projects to be undertaken and funded within the 2011 Unified Budget, as contained in SEC.GAL/145/10, which may be supplemented by fund managers within their respective funds as appropriate in the course of 2011, and which should be updated and distributed to participating States twice in the course of the year;
- 4. Undertakes to intensify efforts, including throughout the Unified Budget cycle in 2011, to focus, streamline and prioritize the work of the Organization across the three dimensions in those areas where it has comparative advantage, and tasks the fund managers to ensure the coherence of their programme activities, in accordance with the body of OSCE principles, commitments and decisions as well as their respective mandates;
- 5. Underlining the continued need to provide Heads of Mission with money to facilitate mandate implementation, decides that in 2011 the ceiling for the Head of Mission Facility will be reduced by 35.7 per cent compared with the ceiling that would be set on the basis of the formula contained in the Permanent Council Decision No. 399 of 14 December 2000;
- 6. Recalling Permanent Council Decision No. 590 of 24 December 2003, decides to amend the OSCE methodology on calculation of the board and lodging allowances by using the 24-month moving average of the UN Retail Price Indexes with details available before submission of the Unified Budget Proposal for the following year;
- 7. Tasks the ACMF to continue discussions in 2011 on Staff Standard Costs issues, in particular staff salaries, with a view to addressing possible major intra-year fluctuations in the future, to ensure the long-term financial sustainability of these costs, and to analyze possibilities for denomination of OSCE staff salaries in euros;
- 8. Tasks the ACMF, in co-ordination with the Secretary General to reflect on the ways to make optimal use of the Unified Budget mid-year review process;
- 9. Reiterates that any request for a supplementary budget during a financial year shall be met, wherever reasonable, by reallocating existing resources;
- 10. Tasks the ACMF, in co-ordination with the Secretary General, to review the issue of local staff income tax in those locations where such tax is still charged;
- 11. Tasks the OSCE Centre in Bishkek, in co-ordination with the Secretary General, to report to the ACMF by 1 March 2011 on the use of the supplementary funds it received in 2010.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Thank you, Mr. Chairman.

Thank you also, Lithuania, for your leadership of the ACMF to pass, for the second time in a row, a budget on time. The United States has joined consensus on the 2011 Unified Budget, as we believe it is extremely important to put the OSCE on a stable financial footing. Having the budget in place ensures that we can devote our attention from January onward to building on the results of the Astana Summit.

The United States of America wishes to make an interpretative statement under paragraph 79 (Chapter 6) of the Final Recommendations of the Helsinki Consultations.

We know that continuing years of Zero Nominal Growth has the effect of decreasing resources the OSCE needs to carry out the mandates and tasks we, as the Permanent Council, give it, a point made frequently by fund managers and the Secretariat over the course of the budget deliberations. We had hoped to see a budget closer to the Secretary General's original proposal. At the same time, we recognize that for some participating States, tough economic choices were made to approve the budget we have before us today.

Given these realities, we must ensure that the resources we contribute are used in a practical manner, and will ask the ACMF Chair to address the issue of improving the OSCE's project assessment and evaluation methodology in 2011, both in connection with the Program Budget Performance Report in spring and throughout the 2012 Unified Budget process.

The United States requests that this statement be recorded in the journal of the day.

Thank you, Mr. Chairman."

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation:

"In connection with the decision that has been adopted by the Permanent Council on the Unified Budged for 2011, we should like to make the following statement.

In the interest of maintaining a consensus and strengthening the compromise that has been reached on reducing budget expenditure, the Russian Federation has displayed goodwill and has supported the decision in question. We hope that this will help the Lithuanian Chairmanship to impart a timely start to the Organization's work in the coming year.

At the same time, a number of important issues directly related to the budget process remain unresolved.

1. The situation remains unclear as regards the financing of the Community Security Initiative, a project involving interaction with the Ministry of Internal Affairs of the Kyrgyz Republic and which is being implemented through the OSCE Centre in Bishkek. In that connection, we insist on the submission of a clear concept for this project, including a detailed description of the budget and a precise breakdown between the budgetary and extrabudgetary components.

2. The practice of using Unified Budget funds to compensate local mission staff for their income tax liabilities is continuing. This is in contradiction to paragraph 5.05 of the OSCE Staff Rules and Regulations. We should like to warn in advance that this situation is no longer tolerable and that there is no point in counting on our agreement to the inclusion of these expenditures in the budget for 2012.

3. We are grateful to the Lithuanian chairmanship of the Advisory Committee on Management and Finance and to our partners for supporting our proposal to use the Head of Mission facility to look for ways of economizing on budgetary resources. We think it advisable to seek greater transparency in the expenditure of funding allocated under this item, as provided for in Permanent Council Decision No. 399 of 14 December 2000.

We would request, Mr. Chairperson, that this statement be attached to the Permanent Council decision that has been adopted and, accordingly, reflected in the journal of today's meeting."
