DECISION No. 7/10 NEGOTIATIONS ON THE VIENNA DOCUMENT 1999

The Forum for Security Co-operation (FSC),

Mindful of the importance of the OSCE politico-military *acquis*, and in particular of the Vienna Document 1999 (VD 99) for promoting security and stability in Europe,

Reaffirming participating States' commitment to full implementation of the *acquis* and to maintaining its relevance,

Recalling Ministerial Council Decision No. 16/09 that, *inter alia* tasked the FSC with strengthening the Vienna Document during 2010,

Re-emphasizing that FSC.DEC/1/10, the VD PLUS decision, which provides a mechanism for regular updates to all parts of the Vienna Document, is in no way invalidated or superseded by the adoption of this decision,

Decides:

1. To update Chapters V and IX of the VD 99;

2. That, on completion of the renegotiation of both chapters, these will supersede the corresponding chapters of the VD 99 and will be incorporated in an updated version of the Vienna Document at an appropriate time (VD 2010, for example).
