**STATEMENT BY  
THE DELEGATION OF THE RUSSIAN FEDERATION**

During the 17th Annual Implementation Assessment Meeting held recently, the delegation of the Russian Federation tentatively already informed the participating States about the adoption of a decision to withdraw the Russian request to the OSCE of 2004 for assistance in the disposal of conventional ammunition in the Kaliningrad oblast amounting to some 100,000 tons, a request which had been submitted in accordance with the OSCE Document on Stockpiles of Conventional Ammunition. Today we are making this official.

The Russian Federation is currently in a position to carry out by its own efforts the large-scale disposal projects begun both in the Kaliningrad oblast and in other regions of the country. However, even though we are declining outside help, in accordance with the spirit of transparency underlying the OSCE Document on Stockpiles of Conventional Ammunition we are nevertheless prepared to inform the participating States about the basic stages of our work to dispose of conventional ammunition on the territory of the Kaliningrad oblast.

We should especially like to thank the Ministry of Defence of Denmark, the Danish delegation to the OSCE and the Senior Military Adviser, Lieutenant Colonel Jorn Rasmussen, personally for his conscientious work as co-ordinator of the Group of Friends of Kaliningrad within the OSCE.
