Mr. Chairman,

I am grateful to delegations for approving the appointment of the National Audit Office as the next External Auditor of the OSCE. I am confident that the National Audit Office will continue the excellent work performed by the Swedish External Auditor over the past four years. I should like to make one point of clarification. The intention is for the National Audit Office to provide external audit services to the OSCE not just for one year, but for a three-year period, as foreseen in Article VIII of the Financial Regulations.
