**The Working Group on cooperation of business community and
government bodies in combating corruption**

The Working group was formed according to the resolution of presidium of Council on combating corruption under the President held on 4 October 2011.

The head of Working group – Elvira Nabiullina, the Minister of Economic Development of Russian Federation.

The Working group includes representatives of:

1. Federal government bodies

-Executive bodies: Ministry of Economic Development of Russia, Ministry of Justice of Russia, Federal Antimonopoly Service of Russia, Ministry of the Interior of Russia

-Highest Courts: Supreme Court, Highest Commercial Court
-State Duma of Russian Federation

2. Business communities

- Trade and Industry Chamber of Russian Federation;
- Russian Union of Industrialists and Entrepreneurs;
- All-Russian business association «Business Russia»;
- Small business cooperation «OPORA Russia».



The key aims of Working Group in 2012

- Participation of business community representatives in discussing draft of federal laws on entrepreneurship and investment areas if considered by State Duma;
- Preparation and discussion draft of Anticorruption charter of Russian business community and standards of anticorruption behavior of business community;
- Anticorruption aspects of procurement development;
- Working out position of business community on prospect development of anticorruption expertise of laws and its drafts;
- Revealing typical corruption layouts by the example of concrete economic branch - construction



Questions of All-Russian business association «Business Russia» according to the Working Group

The offers of business community representatives participation in discussion of drafts of federal laws on entrepreneurship and investment areas if considered by State Duma:

- on introduction of changes to the Rules of State Duma to provide participation of the representatives of business community in discussion of drafts of federal laws on entrepreneurship and investment areas
- in the context of preparation the offers on emending the Governmental Acts, aimed at introduction of regulatory impact assessment (RIA) procedure at the acts preparation amendments



Questions of Russian Union of Industrialists and Entrepreneurs according to the Working Group

1. The Preparation of Anticorruption charter of Russian business community draft

Aim: implementation of the anticorruption model of behavior, ethical norms, forming anticorruption practice to all business community work, implementation of anticorruption standards on the enterprises.

2. Legal Regulating of Lobbying (a special Expert Group was formed)

Aim: preparation of the report on the question of possibility and expediency of Lobbying in Russia.

Aim: preparation of offers on the procurement development by the amendments to the Legislation of Russian Federation.
