It is understood that the Chairman of the Communications Group is authorized to accept, without prejudice, the offer of KPN Telecom as contained in document FSC.GAL/142/99/Rev. 1. Possible modalities of payment of the arrears will be under consideration by the FSC in January 2000 on the basis of proposals prepared by the CPC. The Communications Group will continue to explore the errors encountered with a view to avoiding a repetition of the malfunctioning of the Network. The Chairman of the Communications Group will also continue discussions with those concerned to determine whether there are any liabilities.
