INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the United States of America:

"Thank you, Mr. Chairperson.

The United States wishes to make an interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

In joining consensus on this decision to use the 2018 cash surplus to augment the budget for the Office for Democratic Institutions and Human Rights, the United States makes no commitment to any increases in US contributions in future years due to the use of previous years' cash surpluses in this instance.

I request that this interpretative statement be attached to the decision and to the journal of the day.

Thank you, Mr. Chairperson."
