II. Timetable and other organizational modalities

The Seminar will begin at 9 a.m. (opening ceremony) on 4 November 2002 and end at 6 p.m. on 5 November 2002.

The opening session will be chaired by a representative of the Chairman-in-Office. The closing session will be chaired by the Chairman of Contact Group with the Mediterranean Partners for Co-operation

Each session will have a moderator and a rapporteur appointed by the Chair. The consolidated summary will be forwarded to the Permanent Council for further consideration.

Appropriate arrangements for press coverage will be made.

The working language will be English. At the request of several participating States interpretation will be provided from and into French. These arrangements will not constitute a precedent that can be relied upon in other circumstances.

The speakers will be invited to submit their written statements in advance.

Other rules of procedures and working methods of the OSCE will be applied, *mutatis mutandis*, to the Seminar.

Rooms for additional ad hoc meetings will be made available to participants. Such meetings will be held without interpretation.
