During his studies in Berlin and Birmingham (UK), he had the opportunity to gain experience at the German Federal Constitutional Court, at the British Institute of International and Comparative Law, and at the European Court of Human Rights. In the research group "Towards a Proceduralization of International Law?" of the Max Planck Institute for Comparative Public Law and International Law, he pursues his Habilitation on questions of law and truth.

Prof. Dr. Trisha Meyer

Trisha Meyer is an Assistant Professor of Digital Governance and Participation at the Brussels School of Governance of the Vrije Universiteit Brussel. She leads the Research Centre for Digitalisation, Democracy and Innovation, the BA in Communication and Public Relations, and the Jean Monnet Winter and Summer Schools on EU Policy-Making.

Trisha researches the regulatory push toward and societal consequences of tech platforms taking proactive (automated) measures to moderate online content, with a focus on disinformation and copyright. A second closely related research strand pertains to stakeholder engagement and participatory governance in digital policy.

Professor of Digital Governance and Trisha obtained her PhD and MA in Media and Communication Studies from the Vrije Universiteit Brussel. of She was a Senior Researcher at the University of Turku (Faculty of Law) in 2013-2015, is currently a Professorial Fellow at the United Nations University Institute on Comparative Regional Integration Studies (UNU-CRIS), and will be a Fernandes Fellow at the University of Warwick (Department of Politics and International Studies) in 2021.



Dr. Marko Milanovic Professor of Public International Law at the University of Nottingham School of Law

Marko Milanovic is Professor of Public International Law at the University of Nottingham School of Law. He obtained his first degree in law from the University of Belgrade Faculty of Law, his LL.M from the University of Michigan Law School, and his PhD in international law from the University of Cambridge. He is co-editor of EJIL: Talk!, the blog of the European Journal of International Law, as well as a member of the EJIL's Editorial Board, and was formerly Vice-President and member of the Executive Board of the European Society of International Law. He held visiting professorships at Michigan Law School, Columbia Law School, Deakin Law School, the University of the Philippines College of Law, and the Geneva Academy of International Humanitarian Law and Human Rights. He is an Associate of the Belgrade Centre for Human Rights and was Law Clerk to Judge Thomas Buergenthal of the International Court of Justice in 2006/2007. He has published in leading academic journals, including the European Journal of International Law and the American Journal of International Law; his work has been cited, inter alia, by judges of the European Court of Human Rights, the UK Supreme Court, and the High Court of England and Wales, as well as by the International Law Commission. He was counsel or advisor in cases before the International Court of Justice. the European Court of Human Rights, and the Constitutional Court of Serbia.



Ms. Gabrielle Guillemin

Senior Legal Officer at ARTICLE 19, former consultant for the mandate of the UN Special Representative on freedom of opinion and expression

Gabrielle Guillemin joined ARTICLE 19 in 2011. She leads the organization's work on digital rights policy issues, including platform regulation across all types of content, from terrorism to hate speech and disinformation, as well as on surveillance and cybercrime issues. She recently advised the UN Special Rapporteur for Freedom of Opinion and Expression for her forthcoming report on disinformation. She has led interventions or advised on cases before the European Court of Human Rights, the French Conseil d'Etat, the Supreme Court of Canada, the Court of Justice of the European Union, as well as courts in the UK and Kenya, among others. She has given evidence before the UK House of Lords Committee on social media and criminal offences. From 2013 to 2015, she was a member of the Council of Europe Expert Committee on crossborder flow of Internet traffic and Internet freedoms (MSI-INT), and from 2018-2020 was a member of the MSI-AUT Committee of experts on Human Rights Dimensions of automated data processing and different forms of artificial intelligence. She represents ARTICLE 19 in the transparency and legal frameworks working groups at the Global Internet Forum on Counter Terrorism, and is a member of the advisory network to the ChristChurch Call to eliminate terrorist and violent extremist content. She regularly speaks at public events and conferences on digital rights and internet freedom issues around the world.

Prior to joining ARTICLE 19, Gabrielle worked as a registry lawyer at the European Court of Human Rights for four years. She holds an LLB – Maitrise de droit français (1stClass) from Paris I Pantheon Sorbonne – King's College London, and an MSc Human Rights (Distinction) from the London School of Economics. She was called to the Bar of England and Wales in 2006.

Mr. Alexander Smirnov Executive Secretary of the Academic Council at the Anti-Terrorist Center, Commonwealth of Independent States

Urška Umek is Head of the Media Unit at the Council of Europe's Information Society Department, responsible for developing standards in the area of media freedom and pluralism. She previously worked as a lawyer at the Registry of the European Court of Human Rights (2012 - 2016) and as a lawyer-linguist at the Court of Justice of the European Union (2008). She started her career as a legal adviser at the Constitutional Court of the Republic of Slovenia, where she also headed the Research and International Cooperation Department from 2009 until 2012. She contributed, among others, to the 2011 Commentary to the Constitution of the Republic of Slovenia and to a publication on the reforms of constitutional justice in Slovenia.

Smirnov Alexander Alexandrovich is Executive Secretary of the Scientific Advisory Council at the Anti-Terrorist Center of the CIS Member States. He is also a Candidate of Legal Sciences, Associate Professor. Alexander Smirnov graduated from Moscow University of the Ministry of Internal Affairs of Russia and MGIMO of the Ministry of Foreign Affairs of Russia. Previously, he worked for a long time at the All-Russian Research Institute of the Ministry of Internal Affairs of Russia. He is an expert on countering terrorism and extremism in the digital environment and information security, as well as an author of over 100 scientific publications. He recently authored the scientific and practical manual "Organization of counter-propaganda in the field of combating terrorism and extremism" (2020, in Russian).



Mr. Lutz Güllner

Head of Division for Strategic Communications and Information Analysis, European External Action Service, EU Lutz Güllner is Head of Division for Strategic Communications and Information Analysis in the European External Action Service (EEAS). He leads a team of about 35 people dealing with issues related to disinformation and foreign manipulative interference. In his work, he focuses on addressing disinformation threats for the EU and the EU's neighbourhood region.

He previously served as Head of the EEAS's foreign and security policy communication team (2017-2019) and as Head of the European Commission's Directorate General for Trade's communication team (2013-17). He was also Deputy Head of the Trade Strategy Unit and responsible for the co-ordination of EU-US trade and economic relations.

In 2009 and 2010, Lutz Güllner was spokesperson for the High Representative of the European Union for Foreign Affairs and Security Policy, Catherine Ashton. He was also the Commission's spokesperson for trade policy. In previous positions, he was in charge of economic relations between the EU and Russia. Prior to joining the European Commission, Lutz Güllner worked as public affairs consultant in Brussels.

He studied political science and international relations at the Free University of Berlin and the Institut d'Etudes Politiques (Sciences Po) in Paris. He is teaching trade policy and EU foreign affairs at the post-graduate studies programme for European studies in Berlin.
