STATEMENT BY THE EUROPEAN UNION

The European Union welcomes the adoption by the Permanent Council of the agenda of the High-Level Conference on Tolerance and Non-Discrimination. It thanks the Kazakh Chairmanship of the OSCE for its efforts to reach a consensus among the participating States.

The European Union has shown a great deal of flexibility during the negotiations on this agenda. It greatly regrets that the participating States were unable to reach an agreement on a more ambitious agenda based on a wide-ranging approach to the questions of tolerance and non-discrimination.

The European Union hopes that the delayed adoption of the agenda will not have an impact on the quality of the discussions that will take place in Astana and that this conference will make a genuine contribution to the fight against discrimination regardless of its form.

I would ask you, Mr. Chairperson, to attach this statement to the journal of the meeting.

The candidate countries Turkey and the former Yugoslav Republic of Macedonia*, the Stabilisation and Association Process countries and potential candidate countries Albania, Bosnia and Herzegovina, Montenegro and Serbia, the European Free Trade Association country and member of the European Economic Area Iceland, as well as Ukraine and the Republic of Moldova, align themselves with this statement.

II. Organizational modalities

The opening and closing sessions will be chaired by the OSCE Chairperson-in-Office or a representative of the Chairperson-in-Office.

Each session will have one moderator and at least one rapporteur. The rapporteur(s) will serve as the co-ordinator(s) to prepare the session.

The Rules of Procedure of the OSCE will be applied at the Conference. Also, the guidelines for organizing OSCE meetings (PC.DEC/762) will be taken into consideration.

The participating States are encouraged to be represented by high level officials as well as senior experts responsible for tolerance and non-discrimination issues.

The OSCE institutions will participate in the Conference, as will the Secretary General and the Secretariat. The Parliamentary Assembly and Partners for Co-operation will be invited to participate.

Participation of representatives from international and regional organizations, as well as other relevant actors of civil society and NGOs, would be welcome.

Representatives of non-governmental organizations will be able to attend and contribute to the Conference in accordance with the relevant OSCE provisions.

The discussion in the plenary sessions will be interpreted from and into all six working languages of the OSCE.

The opening and closing sessions will be open to the media.
